Zaremba stated this is their yearly renewal for PC's city wide, approximately 100 machines and we do a 4-year cycle. Price quotes are only good for 30 days and that is why the emergency clause is needed. The roll was called on adding the emergency clause and was approved by the yea votes of P. Rose, J. Shields, D. #### Ord. 015-21:

An Ordinance authorizing the Mayor to advertise for competitive bids and to award a contract to the successful bidder for a one year supply of the various kinds of maintenance materials needed for the streets and water lines, including but not limited to salt, the chemicals for use in the treatment of water meters to be used by various departments of the City of Medina. Mr. Piccoli stated this is their annual bid for materials used in Service and in other departments here in the city. #### Ord. 016-21:

An Ordinance authorizing the expenditure to Goodyear Tire and Rubber Company for the Sanitation Department. Mr. Shields moved for the adoption of Ordinance/Resolution No. 016-21, seconded by Mr. Simpson. Mr. Piccoli stated this ordinance will allow for tire service in the Sanitation Department. Nino stated that the city is well served by this vendor. The roll was called and Ordinance/Resolution No. 016-21 passed by the yea votes of J. Coyne, E. Heffinger, P. Rose, J. Shields, and D. Simpson.

#### Ord. 017-21:

An Ordinance authorizing the expenditure of \$60,000.00 to Signal Service Company for the Streets Department. Mr. Shields moved for the adoption of Ordinance/Resolution No. 017-21, seconded by Mr. Simpson. Mr. Piccoli stated this ordinance will allow for use of the vendor that we use to utilize in the traffic signal program that is above the capacity of our employees. The roll was called and Ordinance/Resolution No. 017-21 passed by the yea votes of E. Heffinger, P. Rose, J. Shields, D. Simpson, J. Coyne.

#### Ord. 018-21:

An Ordinance authorizing the Mayor to advertise for competitive bids and to award a contract to the successful bidder for the East Reagan Parkway Multi-Purpose Trail, Project #1066. Mr. Shields moved for the adoption of Ordinance/Resolution No 018-21, seconded by Mr. Simpson. Mr. Patton stated this trail will extend from where the ODOT installed trail on Rt. 42

An Ordinance authorizing the purchase of new lockers from DeBourgh Manufacturing for the Police Department Locker Room Project. Mr. Shields moved for the adoption of Ordinance/Resolution No. 019-21, seconded by Mr. Simpson. Chief Kinney stated these are lockers for their remodel of the men and women locker rooms at the Police Department. The roll was called and Ordinance/Resolution No. 019-21 passed by the yea votes of J. Shields, D. Simpson, J. Coyne, E. Heffinger, and P. Rose.

#### Ord. 020-21:

An Ordinance authorizing the Mayor to accept three (3) Easements necessary for the East Liberty Storm Sewer Installation Project. Mr. Shields moved for the adoption of Ordinance/Resolution No. 020-21, seconded by Mr. Simpson. Mr. Patton stated this project is part of their residential drainage improvements, it is a smaller project but they did need to acquire three easements to complete it. The roll was called and Ordinance/Resolution No. 020-21 passed by the yea votes of D. Simpson, J. Coyne, E. Heffinger, P. Rose, and J. Shields.

#### Ord. 021-21:

An Ordinance amending Ordinance No. 142-20, passed August 24<sup>th</sup>, 2020, relative to the payment for the Design-Build Contract with CPS Construction, Inc. for design and construction of a City Hall Parking Structure. Mr. Shields moved for the adoption of Ordinance/Resolution No. 021-21, seconded by Mr. Simpson. Mr. Patton stated this is the final agreed amount after some negotiation with CPS Construction. This is for \$30,000 more than original contract but is still below the original budget. The roll was called and Ordinance/Resolution No. 021-21 passed by the yea votes of J. Coyne, E. Heffinger, P. Rose, J. Shields, and D. Simpson.

#### Res. 022-21:

A Resolution amending Res. No. 86-19, passed June 10, 2019, relative to the Small Cities PY19 Community Development Block Grant (CDBG) Program. Mr. Shields moved for the adoption of Ordinance/Resolution No. 022-21, seconded by Mr. Simpson. Mr. Shields moved that the emergency clause be added to Ordinance/Resolution No. 022-21, seconded by Mr. Simpson. Mr. Mendel stated this is to permit the administration to request and accept an amendment to the current PY19 grant allocation. Due to COVID last year and still currently, and deadlines that are set in stone, we will not be able to use the \$20,000 for the new comprehensive plan. In order for the city to retain those dollars that offset General Fund dollars this amendment would allocate the \$20,000 instead to the Parks activity in the current grant. Emergency clause needed due to all activities and payments must be done by August 31<sup>st</sup>. The roll was called on adding the emergency clause and was approved by the yea votes of E. Heffinger, P. Rose, J. Shields, D. Simpson, and J. Coyne. The roll was called and Ordinance/Resolution No. 022-21 passed by the yea votes of P. Rose, J. Shields, D. Simpson, J. Coyne, and E. Heffinger.

#### Ord. 023-21:

An Ordinance amending Ordinance No. 217-20, passed December 14, 2020. (Amendments to 2021 Budget). Mr. Shields moved for the adoption of Ordinance/Resolution No. 023-21, seconded by Mr. Simpson. Mr. Dirham stated these are a couple of appropriation adjustments in the court. The roll was called and Ordinance/Resolution No. 023-21 passed by the yea votes of J. Shields, D. Simpson, J. Coyne, E. Heffinger, and P. Rose.

#### Res. 024-21:

A Resolution authorizing the Mayor to accept and sign the Receipt and Release for a \$75,000.00 donation for the estate of Howard C. Ward, Jr. in memory of the Medina High School Class of 1941, to be used for Christmas Lighting and / or Christmas decorations for the town square. Mr. Shields moved for the adoption of Ordinance/Resolution No. 024-21, seconded by Mr. Simpson. Mr. Huber stated that Mr. Howard Ward Jr. grew up in the City of Medina graduating from Medina High School in 1941 and graciously left to the City of Medina bequest upon his death a donation in the amount of \$75,000.00 asking that the monies be used for Christmas Decorations or Lighting and so the money will be earmarked for that purpose. Mr. Coyne stated what a great honor for the City of Medina to receive such a bequest from a member of the Class of 1941. We are honored and thankful for this bequest. The roll was called and Ordinance/Resolution No. 024-21 passed by the yea votes of D. Simpson, J. Coyne, E. Heffinger, P. Rose, and J. Shields.

#### Ord. 025-21:

An Ordinance authorizing the Mayor to enter into a contract with Gatchell Grant Resources to work on the City's behalf to apply for an Assistance to Firefighters Grant (AFG) for the replacement of air tanks for the Fire Department. Mr. Shields moved for the adoption of Ordinance/Resolution No. 025-21, seconded by Mr. Simpson. Mr. Shields moved that the emergency clause be added to Ordinance/Resolution No. 025-21, seconded by Mr. Simpson. Mayor Hanwell stated this grant is for the self-contained breathing apparatus that our Firemen use. We were not successful last attempt at this grant and would like to try for it again. Emergency clause is needed due to paperwork deadlines. The roll was called on adding the emergency clause and was approved by the yea votes of J. Coyne, E. Heffinger, P. Rose, J. Shields, and D. Simpson. The roll was called and Ordinance/Resolution No. 025-21 passed by the yea votes of E. Heffinger, P. Rose, J. Shields, D. Simpson, and J. Coyne.

Mr. Simpson thanked Damion and Joshua from Cub Scout Pack #3500 for their hard work and we are always proud when someone comes up to get this recognition that they obviously deserve. He also thanked Mr. Gladish for his hard work in receiving his most recent certification, offered his sympathies to the Berarducci family, and reminded everyone to be kind to one another.

Mr. Rose congratulated the Scouts, telling them to keep up the good work. He made his annual comment to please keep the fire hydrants clear and stated we are in that time of the year where more snow is expected, so clear the hydrants of ice and snow to make it easier for the firefighters,

#### **ORDINANCE NO. 26-21**

AN ORDINANCE APPROVING THE THREE YEAR CAPITAL IMPROVEMENT PLAN FOR THE MEDINA COMMUNITY RECREATION CENTER AND AUTHORIZING THE EXPENDITURE OF THE CURRENT CASH BALANCE OF THE FUND TO THE MEDINA CITY SCHOOLS, IN ACCORDANCE WITH THE JOINT OPERATING AGREEMENT.

- WHEREAS: Ordinance No. 101-01, passed July 9, 2001 authorized the Joint Operating Agreement and Lease Agreement between the Board of Education of the Medina City School District and the City of Medina for the operation of the Medina Community Recreation Center; and
- **WHEREAS:** Section 5.6 of the Operating Agreement establishes a Capital Improvement Fund specifically to address future capital needs; and
- WHEREAS: Section 5.6 also specifies that the Capital Improvement Plan be recommended by the Advisory Committee before the beginning of each contract year and shall be approved by each party; and
- WHEREAS: On January 21, 2021, the Recreation Advisory Committee approved the Capital Improvement Plan and expending of capital funds; and
- WHEREAS: On February 8, 2021 the Finance Committee approved the plan.

- SEC. 1: That in accordance with Section 5.6 of the Joint Operation Agreement between the Board of Education of the Medina City School District and the City of Medina, the Capital Improvement Plan for the Medina Community Recreation Center is hereby approved.
- SEC. 2: That a copy of the Plan is marked Exhibit A, attached hereto and incorporated herein.
- SEC. 3: That the expenditure to Medina City Schools is hereby authorized, and the funds are available in Account Number 575-0350-54420.
- SEC. 4: That in accordance with Ohio Revised Code §5705.41(D), at the time that the contract or order was made and at the time of execution of the Finance Director's certificate, sufficient funds were available or in the process of collection, to the credit of a proper fund, properly appropriated and free from any previous encumbrance.

- WHEREAS: Ordinance No. 184-20, passed October 26, 2020 authorized the Mayor to advertise for competitive bids and to award a contract to the successful bidder for the Rotunda Renovation Project at Medina City Hall; and
- WHEREAS: On March 9, 2020, Governor Mike DeWine declared a State of Emergency in Executive Order 2020-01D in order to protect the welfare of citizens of Ohio from the dangerous effects of COVID-19;
- WHEREAS: On March 27, 2020, the President of the United States signed into law the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") which, in part, established the coronavirus relief fund under 42 U.S.C. 8801 and appropriated 150 billion dollars of direct payments to states, tribal governments, and units of local government;
- WHEREAS: On June 19, 2020, Governor Mike DeWine signed into law House Bill 481 which authorizes distribution of federal coronavirus relief fund money to eligible counties, townships, and municipal corporations in Ohio;
- WHEREAS: The City of Medina is the recipient of federal coronavirus relief fund money;
- WHEREAS: The CARES Act and H.B. 481 require that recipients of federal coronavirus relief funds must use the relief funds to cover only those costs that are necessary expenditures incurred due to the public health emergency with respect to COVID-19, were not accounted for in the budget most recently approved as of March 27, 2020 for the unit of government, and were incurred during the period between March 1, 2020 and December 30, 2020;
- WHEREAS: This Council determines that the cost of the rotunda renovation project at Medina City Hall is a necessary expenditure due to the public health emergency with respect to COVID-19 in order to curb the transmission and spread of COVID-19 by creating a larger physical space in which members of the public may gather and remain sufficiently distanced from another;
- WHEREAS: This Council further determines that the cost of the rotunda renovation project at Medina City Hall was not accounted for in the budget most recently approved as of March 27, 2020, and the cost will be incurred between March 1, 2020 and December 30, 2020;
- WHEREAS: That Section 2 of Ordinance 184-20, passed October 26, 2020 currently reads as follows:

SEC. 2: That the estimated cost of the project, in the amount to be determined, is available in Account No. 170-0743-52215.
