- 1. Assignment of Requests for Council Action
- 2. <u>18-138-7/9 Consider Legislation Prohibiting Feeding Deer/Wild Animals</u> Mr. Lamb stated this discussion started in 2018. Tried to make language flexible, and at last meeting they have arrived at a proposal. Mr. Lamb doesn't feel it is overly enforceable. John stated this may be another way that we are able to address an issue if there is a problem that is causing damage to neighboring properties caused by feeding the deer. Mr. Shields moved to approved, seconded by Mr. Simpson. Motion passed 6-1. Bill Lamb cast a nay vote.
- 3. <u>23-073-3/13 Amend S&B 31.05 Add one (1) Full-Time Dispatcher Police</u> Mr. Simpson believes Chief Kinney's request is reasonable and understandable. Chief is asking for another full-time dispatcher. Mr. Shields moved to approved, seconded by Mr. Simpson. Motion passed 7-0.
- 4. <u>23-108-5/22 Communications Radio Console Upgrade Police</u> Chief Kinney stated both of these next items are regarding an upgrade in their communications center. They are at end of life and need upgraded. Mr. Shields moved to approved, seconded by Mr. Simpson. Motion passed 7-0.
- 5. <u>23-109-5/22 Communications Dark Fiber Services Agreement & Service Fees</u>
 Chief Kinney stated this is the network connection and the county pays a monthly lease fee.
 Mr. Shields moved to approved, seconded by Mr. Simpson. Motion passed 7-0.
- 6. <u>23-110-5/22 PY23 CDBG Allocation Grant</u>
 Andrew Dutton stated this is the CDBG application. Emergency clause is needed because of the application deadline. Mr. Shields moved to approved with the emergency clause, seconded by Mr. Simpson. Motion passed 7-0.

- 7. <u>23-111-5/22 Increase PO #23-1070 R&T Fence, Inc. Parks</u> Mayor Hanwell stated the increase would total \$20,000 to repair or replace damaged backstop fencing and baseline fencing at Greenwood Park and Reagan Park. Mr. Shields moved to approved, seconded by Mr. Simpson. Motion passed 7-0.
- 8. <u>23-112-5/22 Purchase 2024 Mack TE Front Loader Sanitation</u>
 Nino Piccoli stated this would be replacing a 2000 Mac that served the city for 20 years. \$386,000 for a front loader. Mr. Shields moved to approved, seconded by Mr. Simpson. Motion passed 7-0.
- 9. <u>23-113-5/22 Increase PO #23-0930 Wheeling & Lake Erie Engineering</u> Patrick stated this is to cover the cost of flaggers. Mr. Shields moved to approved, seconded by Mr. Simpson. Motion passed 7-0.
- 10. <u>23-114-5/22 Increase PO #23-840 Rocco Masonry Streets</u>
 Nino stated this would handle a couple more aprons that are affected by the storm sewers.
 Mr. Shields moved to approved, seconded by Mr. Simpson. Motion passed 7-0.
