# Reports of Municipal Officers:

# Dennis Hanwell, Mayor

- A. Covid-19- Medina County moved to level two, Orange. Well done! Non-vaccinated constituents are still encouraged to wear masks and social distance. Effective June 2, all of the current COVID-19 restrictions will be lifted by the OH Department of Health. Exception would be quarantine and isolation orders from Health Department as those are covered in existing ORC provisions for over 70 illnesses. County may move to yellow with our reduced numbers of cases possibly this Thursday, May 27th.
- B. Memorial Day service Monday, May 31 at 11 a.m. NO PARADE!
- C. Thoughts and prayer to family of Richard Dirham- Local business man, Councilperson, and Marine- father of our Finance Director Keith Dirham.
- D. **July 4**th **activities-** Fireworks will be set off at dark on July 3<sup>rd</sup>. All COVID-19 restrictions will be lifted effective June 2nd. The July 4th parade will line up at west lot of Medina HS at 3 p.m., and parade starts promptly at 4 p.m. Again, no COVID-19 restrictions will exist at that date unless added between now and then. CANDY MAY NOT BE THROWN FROM VEHICLES! We are asking all parade entries to display an American flag to honor our Independence Day. We do not expect new restrictions, but if any new COVID restrictions are added, we will share with newspapers and on social media.
- E. **Medina Community Band-** planning to have a July 4th concert at the Bandstand area vs Gazebo to spatially distance. The concert is tentative provided they may find rehearsal location and is weather dependent. More details to follow.
- F. Issue 1 Passes- I am thankful and appreciative that the Medina city voters passed Issue 1 on May 4. We have been working on a resolution for space and safety issues at the Medina Municipal Court for over two decades. This approval will permit the City of Medina to partner with Medina County which makes the most sense both operationally and fiscally for both the city and the county. Thank you to the Medina City voters!
- G. **Thankful** that Medina outdoor pool will be open Saturday, May 29th with no restrictions as well as our splash pads, Greenwood and Mellert Parks, will both open without restrictions June 2. With the lifting of the COVID-19 restrictions.

Keith Dirham, Finance Director, stated they've talked a few times about the American Rescue Plan Funds, there have been some updates. The Feds have dropped some guidance and we've had some webinars on it and now they are dropping changes to their guidance.

Keith stated they are working through the budget software and will soon be ready to move forward. Keith thanked the Mayor for his kind words about his Father's passing. Keith stated that his father was a councilman for the City of Medina for 16 years. Richard Dirhams' model was to enjoy every day and try to make the world a little better place for having been here.

Greg Huber, Law Department, had no report.

Chief Kinney, Police Department, stated that the Medina Police Department is hiring for the position of Patrol Officer. Interested candidates can find information and apply at <a href="https://www.medinaoh.org">www.medinaoh.org</a> under the employment tab. Application deadline is May 26<sup>th</sup> and written test is June 2<sup>nd</sup>. The successful candidates will move on to a physical fitness test at a later date.

Chief Walters, Fire Department, had no report.

Kimberly Marshall, Economic Development Director, had no report.

Jansen Wehrley, Parks and Recreation Director, updated everyone stating the beginning of last week they were able to install their permanent vault restroom at Sam Masi Park. This was purchased collaboratively with donations from the Stephenson Foundation as well as the Miracle League of Northeast Ohio. This permanent restroom is fully ADA accessible and will be a great addition to the park and The Medina Lions Miracle League field for the children over there. Jansen stated they are in the process of extending the Multi-Purpose trail on East Reagan Parkway and have been getting a lot of inquiry from the community. This trail will run from Larkens Way to North Court Street and is utilizing a Clean Ohio Trails Grant. The outdoor pool will open May 29<sup>th</sup> as long as the weather is above 70 degrees.

Hours of operation are Monday – Thursday 11 a.m. – 6 p.m. Closing earlier due to offering outdoor swimming lessons. Registration for that starts on June 1<sup>st</sup>.

Fridays and Saturdays  $\overline{11}$  a.m. -7 p.m. including Memorial Day and Labor Day.

With the Governor lifting the restrictions on June 2<sup>nd</sup> we have prepared and have filled up the splash pads as of last week and plan to be fully operational on June 2<sup>nd</sup>.

Hours at Greenwood Park are 11 a.m. – 8 p.m. Ray Mellert Park hours are 12 p.m. – 8 p.m. Monday through Sunday.

Jansen stated the staff has worked hard to make sure that those are available to be open. They have taken additional measures to use some CARES Act Funding to install touchless sensors, activators and make it as safe as possible over there.

Just released advertisements for their Party in the Parks Program sponsored collaboratively with the Cleveland Clinic doing an 8-week series at various parks utilizing recreation center staff from their summer camp to have free fun activities. Information can be found on Facebook page or on the Medina Community Recreation Center Website. Registration is required.

The roll was called and Ordinance/Resolution No. 082-21 passed by the yea votes of E. Heffinger, B. Lamb, P. Rose, J. Shields, D. Simpson, J. Coyne, and J. Hazeltine.

### Ord. 083-21:

An Ordinance authorizing the Mayor to accept the Fee Proposal from GPD Group to modify the water line within ODOT's SR 18 Corridor Project. Mr. Shields moved for the adoption of Ordinance/Resolution No. 083-21, seconded by Mr. Simpson. Mr. Patton stated that late last year our city's water consultant completed a hydraulic analysis of our water system and one of their recommendations was that the city should consider abandoning some of our larger watermains on

the east side of our city as they are no longer necessary or pertinent to our system. Part of the RT 18 ODOT project was to replace some of these very lines and now ODOT is willing to allow us to modify their plans at their expense and that is what this cost is for. The roll was called and Ordinance/Resolution No. 083-21 passed by the yea votes of B. Lamb, P. Rose, J. Shields, D. Simpson, J. Coyne, J. Hazeltine, and E. Heffinger.

### Ord. 084-21:

An Ordinance authorizing the Mayor to accept two (2) Easements necessary for the North Broadway Bridge Replacement Project. Mr. Shields moved for the adoption of Ordinance/Resolution No. 084-21, seconded by Mr. Simpson. Mr. Patton stated that they will be completing a replacement culvert at North Broadway/Spring Grove this summer and some easements are needed to complete this project. #### **ORDINANCE NO. 91-21**

AN ORDINANCE AUTHORIZING THE JOB CREATION GRANT PAYMENT OF \$33,717.45 TO SANDRIDGE FOOD CORPORATION.

- WHEREAS: Ordinance No. 154-07, passed September 24, 2007 adopted a Job Creation Grant Program for the City of Medina, Ohio to provide incentives to businesses to retain, create and expand employment opportunities within the City of Medina without utilizing tax revenues or impacting negatively upon the local school system; and
- WHEREAS: Ordinance No. 194-14, passed November 24, 2014, adopted new guidelines effective December 24, 2014; and
- WHEREAS: Ordinance No. 45-13, passed March 25, 2013, authorized the Job Creation Grant Agreement #JCG04 for Sandridge Food Corporation; and
- WHEREAS: Ordinance No. 17-17, passed February 13, 2017, authorized the Job Creation Grant Agreement #JCG12 for Sandridge Food Corporation; and
- **WHEREAS:** The Business Development Committee met to review the progress of these two grants and is recommending the payment of \$33,717.45 (\$22,500.00 for JCG04 & \$11,217.45 for JCG12).

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:

Specific Areas for "Donation Recognition" opportunities:

- **Field House** (basketball courts) 24,000 SQ FT. open area heavily used by participants and their families during basketball league season. This area is also used by Medina High School student physical education classes and general athletic programs.
- Natatorium Pools Two separate pool areas
  - Competition Pool 300k gallon pool with prominent score and statistic boards that could be a donation opportunity when replaced. The pool has contracts to host USA Swimming competitions, and is the home of Medina High School Swim Team, and Medina Recreation Swim Teams. This pool also provides diving, scuba and water fitness programs, and general MCRC membership lap swimming.
  - Leisure Pool 115k gallon pool with slide and play feature heavily used for fitness classes, swim lessons for infants through adults, physical therapy via Medina Hospital/Cleveland Clinic, and general MCRC membership leisure activities.
- **Fitness Room** approx. 6,700 SQ FT, two level exercise facility with numerous cardio machines, dedicated free weight area, and selectorized weight machines. The Fitness Room is located in a highly visible area within view of the main entrance.
- Indoor Walking /Running Track 10,000 SQ FT. Four lane, oval track with a continuous interior wall that could be utilized for donation recognition as well as rotating advertisement displays, etc.
- Community Rooms B & C Meeting rooms can hold up to 100 patrons and host regularly scheduled, very well attended, senior lectures, rentals, and the MCRC Discovery Camp.
- Front Lobby and Concourse Large, two-story open area connecting main entrance, pools, meeting rooms and the Field House.

These are just some of the ideas for donation recognition opportunities. The MCRC is open to other creative ideas, like printing approved donor messages on the reverse side of its membership ID cards that are currently blank on the back. The MCRC also has a website and Wi-Fi available for patron use.

### Matters to consider:

- 1. The fee schedule in the proposal should be performance based, as there will be no funding from the MCRC for initial or ongoing expenses to attract donors, so those expenses should be factored into the proposed fee schedule.
- 2. Priority will be given to the dynamic and pre-existing relationship the City of Medina and Medina City Schools have with the Cleveland Clinic/Medina Hospital

which has recognition and appreciation signage and materials related to its donations to the MCRC. This relationship may conflict with donations solicited from other health care organizations. The Cleveland Clinic has reserved the right to object to any competing organization's participation in the MCRC Donation Recognition Program or the level of such participation.

- 3. The RAC, Medina City Schools, and the City of Medina, must approve all prospective donors, signage, or items included in the donor packages, <u>including the specific content thereof</u>.
- 4. The MCRC building's overall naming rights will not be considered at this time, nor will any exterior building signage or other features.
- 5. The MCRC will reserve the right to solicit for event sponsorships for specific special events, but may consider proposals for these events.

# BRANDSTETTER CARROLL INC. STANDARD PROVISIONS

- (1) Consultant's Scope of Services and Additional Services. The Consultant's undertaking to perform professional services extends only to the services specifically described in this Agreement. However, if requested by the Client and agreed to by the Consultant, the Consultant will perform additional services ("Additional Services"), and such Additional Services shall be governed by these provisions. Unless otherwise agreed to in writing, the Client shall pay the Consultant for the performance of any Additional Services an amount based upon the Consultant's then-current hourly rates.
- (2) Client's Responsibilities In addition to other responsibilities described herein or imposed by law, the Client shall:
  - (a) Designate in writing a person to act as its representative with respect to this Agreement, such person having complete authority to transmit instructions, receive information, and make or interpret the Client's decisions.
  - (b) Provide to the Consultant all previous studies, plans, or other documents pertaining to the project and all new data reasonably necessary in the Consultant's opinion, such as site surveys and engineering data, environmental impact assessments or statements, zoning or other land use regulations, etc., upon all of which the Consultant may rely.
  - (c) Arrange for access to the park sites and other public property as required for the Consultant to provide its services.
  - (d) Review all documents or reports presented by the Consultant and render in writing decisions pertaining thereto within a reasonable time so as not to delay the services of the Consultant.
  - (e) Give prompt written notice to the Consultant whenever the Client becomes aware of any development that affects the scope and timing of the Consultant's services or any defect or noncompliance in any aspect of the project.
- (3) **Period of Services Unless** otherwise stated herein, the Consultant will begin work timely after receipt of an executed copy of this Agreement and will complete the services in a reasonable time. This Agreement is made in anticipation of conditions permitting continuous and orderly progress through completion of the services. Times for performance shall be extended as necessary for delays or suspensions due to circumstances that the Consultant does not control.
- (4) **Method of Payment -** Compensation shall be paid to the Consultant in accordance with the following provisions:
  - (a) Invoices will be submitted by the Consultant to the Client periodically for services performed and expenses incurred. Payment of each invoice will be due within 30 days of receipt.
- (5) **Termination** The obligation to provide further services under this Agreement may be terminated by either party upon seven days' written notice in the event of substantial failure by the other party to perform in accordance with the terms hereof through no fault of the terminating party, or upon thirty days' written notice for the convenience of the terminating party. In the event of any termination, the Consultant shall be paid for all services rendered and expenses incurred to the effective date of termination, and other reasonable expenses incurred by the Consultant as a result of such termination. If the Consultant's compensation is a fixed fee, the amount payable for services will be a proportional amount of the total fee based on the ratio of the amount of the services performed, as reasonably determined by the Consultant, to the total amount of services which were to have been performed.
- (6) Insurance The Consultant is protected by Workers' Compensation insurance, professional liability insurance, and general liability insurance and will exchange certificates of insurance upon request. If the Client directs the Consultant to obtain increased insurance coverage, or if the nature of the Consultant's activities requires additional insurance coverage, the Consultant will take out such additional insurance, if obtainable, at the Client's expense.

- (7) **Standard of Care** In performing its professional services, the Consultant will use that degree of care and skill ordinarily exercised, under similar circumstances, by reputable members of its profession in the same locality at the time the services are provided. No warranty, express or implied, is made or intended by the Consultant's undertaking herein or its performance of services, and it is agreed that the Consultant is not a fiduciary with respect to the Client.
- (8) **Dispute Resolution** All claims by the Client arising out of this Agreement or its breach shall be submitted first to mediation in accordance with the Construction Industry Mediation Rules of the American Arbitration Association as a condition precedent to litigation. Any mediation or civil action by Client must be commenced within two years of the accrual of the cause of action asserted but in no event later than allowed by applicable statutes.
- (9) Assignment and Subcontracting This Agreement gives no rights or benefits to anyone other than the Client and the Consultant, and all duties and responsibilities undertaken pursuant to this Agreement will be for the sole benefit of the Client and the Consultant. The Client shall not assign or transfer any rights under or interest in this Agreement without the written consent of the Consultant. The Consultant will utilize the services MySidewalk (formerly MindMixer) for the online civic engagement as presented in the Consultant's Qualifications Submittal to the Client. No other sub-consultants will be utilized without the written consent of the Client.
- (10) Miscellaneous Provisions This Agreement is to be governed by the law of the State of Ohio. This Agreement contains the entire and fully integrated agreement between the parties and supersedes all prior and contemporaneous negotiations, representations, agreements or understandings, whether written or oral. Except as provided in Section 1, this Agreement can be supplemented or amended only by a written document executed by both parties. Provided, however, that any conflicting or additional terms on any purchase order issued by the Client shall be void and are hereby expressly rejected by the Consultant. Any provision in this Agreement that is unenforceable shall be ineffective to the extent of such unenforceability without invalidating the remaining provisions. The non-enforcement of any provision by either party shall not constitute a waiver of that provision nor shall it affect the enforceability of that provision or of the remainder of this Agreement.
