### Call to Order:

Medina City Council met in regular session on Monday, June 14, 2021 at Medina City Hall. The meeting was called to order at 7:30 p.m. by Council President John Coyne III who led in the Pledge of Allegiance.

### Roll Call:

The roll was called with the following members of Council present E. Heffinger, B. Lamb, P. Rose, J. Shields, D. Simpson, J. Coyne, and J. Hazeltine.

### Minutes:

Mr. Shields moved that the minutes from the regular meeting on Monday, May 24, 2021, as prepared and submitted by the Clerk be approved, seconded by Mr. Simpson. Keith Dirham, Finance Director, stated there are a few things on the agenda that he will address.

Greg Huber, Law Department, extended well wishes to Sandy Davis in her retirement

expressing she was great to work with and she will be missed.

Chief Kinney, Police Department, wished Sandy Davis a Happy Retirement.

Chief Walters, Fire Department, reported on a fire at the Liberty Plaza Apartments on Thursday morning of last week. This fire was in a multipurpose building that housed Rental offices, a Community Center, the laundry area and maintenance area. When they arrived, the attic area of the maintenance side of the building was already heavily engulfed in fire and was beginning to spread to the other attic area of the building. Chief Walters reported that Medina City Police arrived early in the incident and were able to quickly deploy one of the city's Drones and this provided us with both an aerial view of the fire conditions and additionally, they were able to use the thermal imagining capabilities of the drone to see the heat signatures of the attic which enabled the fire fighters to more quickly determine where those interior crews needed to be placed and operating. The drone and the officers proved to be an invaluable resource at this fire and he truly believes they assisted the firefighters in stopping the fire and saved the largest part of that building. Chief Walters thanked Chief Kinney and his officers for their quick response and assistance and he thanked the crews from the Medina Life Support Team from the Cleveland Clinic Medina Hospital, they did more than just provide rehab, many of them have been cross trained as firefighters and they assisted with many firefighting activities early in the operation. Chief Walters stated they are all aware of the unique collaboration they have here in Medina with the safety forces, the Medina Police Department and LST, assisting the Medina Fire Department at this incident truly was something special to see.

Kimberly Marshall, Economic Development Director, had no report but wanted to wish Sandy Davis a Happy Retirement and thanked her for all her help and support over the last ten years.

Jansen Wehrley, Parks and Recreation Director, was absent.

Cindy Latuska, Municipal Court, had no report.

Dan Gladish, Building Official, reported that the department continues to see building improvements, alterations and new construction along North Court Street. New construction includes Taco Bell, Chick-fil-A, Jiffy Lube. Discount Tire is under construction and expected to be completed by the end of July. The County Court Project started some minor construction last Thursday.

Jonathan Mendel, Planning Community Director, extended congratulations to Sandy on her retirement stating that she has been a critical part of the function of the three divisions within the Community Development Department.

Nino Piccoli, Service Director, extended well wishes to Sandy Davis on her retirement.

Patrick Patton, City Engineer, reported that they are under construction with the East Reagan Parkway Multi-Purpose Path Project. Starting tomorrow June 15<sup>th</sup>, the driveway entrance to BP Gas Station will be closed for three days to allow for the replacement of the drive apron.

### Ord. 095-21:

Mr. Shields moved for the adoption of Ordinance/Resolution No. 095-21, seconded by Mr. Simpson. We are at a point in ODOT's project development process we are authorized to begin right-of-way acquisition. The roll was called and Ordinance/Resolution No. 095-21 passed by the yea votes of D. Simpson, J. Coyne, J. Hazeltine, E. Heffinger, B. Lamb, P. Rose, and J. Shields.

### Ord. 096-21:

An Ordinance amending Section 31.05 of the Salaries and Benefits Code of the City of Medina, Ohio relative to Patrol Officers in the Police Department. Mr. Shields moved for the

adoption of Ordinance/Resolution No. 096-21, seconded by Mr. Simpson. Chief Kinney stated this will increase the Patrol Officer allocation from 29 to 32, this is an increase of 3 officers that will be paid for by contractual revenue from Lafayette Township, for two officers and MCDAC grant funding for the third officer. The roll was called and Ordinance/Resolution No. 096-21 passed by the yea votes of J. Hazeltine, E. Heffinger, B. Lamb, P. Rose, J. Shields, and D. Simpson. Mr. Coyne cast a nay vote.

Half of which comes from the Court's Special Projects Fund and the other half from the City's Capital Improvement Fund and it is to look at the needs of the Municipal Court within the 1969 Common Pleas building. This will allow us to plan and work through this in the time that the county is building their new courthouse which will take an estimated 24 months. The roll was called and Ordinance/Resolution No. 099-21 passed by the yea votes of P. Rose, J. Shields, D. Simpson, J. Coyne, J. Hazeltine, E. Heffinger, and B. Lamb.

### Ord. 100-21:

An Ordinance amending Ordinance No. 217-20, passed December 14, 2020. (Amendments to 21021 Budget) Mr. Shields moved for the adoption of Ordinance/Resolution No. 100-21,

seconded by Mr. Simpson. Mr. Dirham stated that these are amendments to the 2021 to cover expenditures. The roll was called and Ordinance/Resolution No. 100-21 passed by the yea votes of J. Shields, D. Simpson, J. Coyne, J. Hazeltine, E. Heffinger, B. Lamb, and P. Rose.

### **Council Comments:**

Mr. Simpson expressed well wishes to Sandy Davis on her retirement. Please just be kind to each other.

Mrs. Hazeltine announced two events in June. June is of course Pride Month and she explained what Pride Month means stating that Pride Month commemorates the Stonewall riots where police raided the Stonewall Inn which had become a safe haven for the LGBTQA+ community, at the time it was illegal in almost every state for restaurants to employ or allow homosexual individuals into their establishments so that night the LGBTQA+ community took a stand and declared they were going to be in charge of determining their own identity. As a result, you will see a lot of events being held during Pride Month. Three Presidents have declared the month of June PRIDE Month under three different administrations but basically it is a celebration of what the LGBTQA+ Community has made an impact on the world.

The second event in June is Juneteenth which is this Saturday. This is something that is not been widely taught in history books so a lot of people are not aware of what Juneteenth is. Juneteenth celebrates the emancipation of slaves in the United States. You would think ok - the Emancipation Proclamation was in 1862 - but this was actually when word filtered down all the way to Texas. The southern most part of the United States finally reached that when Union Army General Gordon Granger proclaimed freedom from slavery in Texas by reading the announcement of General Order #3. These are your two informational things for today, so please take a moment this Saturday to recognize the importance of that and all month long for Pride Month.

Jess congratulated Sandy Davis on her retirement and thanked all safety forces for their quick response to the fire at Liberty Plaza.

Mr. Lamb thanked Fire Chief Walters for his explanation about the fire but most of all, his comments on the importance of collaborating and how working together you get good results. Bill thanked the Charter Review Commission for there work.

Mr. Rose congratulated Sandy Davis on her retirement. Paul also thanked the voters for the May 4th outcome. It was a hard-fought battle against a team that called themselves "Stop Government Waste" and I'd like to let you know how much money "Stop the Government Waste" cost the city in legal fees - \$63,000.00 and that is over and above Mr. Huber's salary and his department salary. These are dollars we had to spend on outside assistance, we were sued about the ordinance that put the courthouse in play for the city plan working with the county. The judge ruled in our favor! In addition to that, they opposed the ballot language that was put on the ballot for the May 4th election that was passed by the city residents to use the 1969 courthouse for the Municipal Court. The Supreme Court of Ohio ruled in favor of Medina City. Lastly there is a tax payer law suit going on about some meetings that were held and that right now is going through the process but

seems there is some stalling going on to slow down the case. This is where your tax dollars are going! Take a better look at who is wasting government money.

Mr. Coyne read a letter that was received from Ned Simpson and Paul Ryan who are both co-executors of the Estate of Howard C. Ward Jr. (included in minutes)

The City of Medina is honored that Howard wanted to gift the city of Medina with \$75,000 for Christmas Lights. We thank Howard and his family.

There will be a budget meeting on Wednesday in the rotunda at 5:00pm.

There being no further business, the meeting adjourned at 8:13 p.m.

Enclosed is a check for \$75,000.00 which Howard Ward, Jr. wanted to go to the city upon his passing for Christmas lights and decorations on town square and if desired the immediate configuous business district

This is what I have come to understand the family's Medina history. Howard Ward Sr, his wife Carrie and their son Howard Jr. moved to 221 North Broadway in 1937. I've enclosed a photo of the house from 1950. A 1937 picture shows Carrie Annette Bell in front of 221 No. Broadway after the death of her husband Dr. J. W. Bell is also enclosed. The widow Bell moved into the part of the house that had been the doctor's office and the Wards occupied the residential area. Howard, "Bud" or "Buddy" graduated from Medina High School in 1941. Shortly after graduation Howard joined the Navy. Pve also enclosed a picture of him from that time.

Howard never married and had not children. My sister, Howard's niece and I are the closest remaining relatives. Although Howard spent the rest of his life after the Navy in Schenectady NY where he had a career with General Electric there remained a tie to Medina. His father passed away at 221 No Broadway in 1970, Carrie sold the house in 1979.

Reflecting his Medina ties, bequests were also made the Medina Methodist Church, Medina Masonic Lodge and the Medina Masonic Home.

It has been disappointing and rather frustrating that it has taken so long to work through all the questions with the Surrogate Court to get to this point. It is however a short time in the context that we will long remember Howard.

CLASSIFICATION FEATURES: The individual in this classification performs a variety of pre-production, production and post-production duties under the direct supervision of the Cable TV Executive Director/General Manager. The position requires the ability to accept a production project from inception to completion with no additional training or guidance, as well as the ability to assist in the supervision and training of volunteers in production situations. The individual will also oversee and manage the usage of the Medina Performing Arts Center (PAC) in all technical aspects and operating conditions operations for school, community and professional events that take place at PAC.

The Board of Education of the Medina City School District agrees to pay to the City of Medina/MedinaTV the amount due for salary for the Technical Operations Director position. The hourly rate for this position is a 14 A-F in the salary and benefits code for the City of Medina. The pay for this position is currently at \$37.83 per hour. MedinaTV(City) will invoice the School District and payments will be made quarterly for this position.

The shared position will be split 40 hours to Medina TV and 40 hours to the Medina City School District Performing Arts Center per bi-weekly pay period. The split of hours will be periodically reviewed and can be revised by mutual agreement between both parties. All Administrative responsibilities for the position including performance reviews will be handled by Medina TV with input from the School District.

The Parties agree that the position of Technical Operations Director will be reviewed annually as part of a budgetary review process. If either party feels they can no longer afford to continue funding the position, either party must give written notice to the other party of their intent to terminate this agreement at least 90 days prior to December 31<sup>st</sup>.

#### **EXPLANATION OF BILLING RATES and CHARGES**

Ohio law requires the Auditor of State to charge public offices the total cost of audits conducted, ORC 117.13

However, the law also provides that, for *local public offices*, AOS audit charges shall be offset based on resources provided by the Ohio General Assembly. Resources currently available to subsidize AOS audit costs are the Local Government Audit Support Fund (LGASF)[1] and the state General Revenue Fund.

For **state agencies**, AOS audit charges are offset to comply with federal cost recovery guidelines by a subsidy provided by the Ohio General Assembly from the state General Revenue Fund.

The current federally approved cost recovery rate for **local public offices** is \$75.69. The subsidized AOS rate charged is \$41.00 per hour.

The current federally approved cost recovery rate for state agencies is \$96.21. The current subsidized AOS rate charged to state agencies is \$79.00 per hour.

For audit services performed by AOS interns, the AOS rate is 50 percent of the otherwise applicable rate.

The current subsidized AOS rates are financially feasible only due to state appropriations made by the Ohio General Assembly from the Local Government Audit Support Fund and the General Revenue Fund.

[1] The Auditor of State's Office proposed establishment of the LGASF in FY 2020 is to avoid an immediate and substantial increase in audit charges for AOS local audit clients.

### NOTICE TO DELINQUENT ACCOUNTS

A failure to pay the Auditor of State in full within forty-five days of the payment due date identified on this invoice shall constitute a delinquent account. Failure to make payment will result in the delinquent account being certified to the Ohio Attorney General's Office, Collection Enforcement, for collection under Ohio Revised Code 131.02(A). Alternatively, Ohio Revised Code section 117.13 (D) authorizes the Director of the Office of Budget Management or the county auditor, in order to satisfy certified balances owed to the office of the Auditor of State, to withhold from a public office with delinquent accounts any amounts that are available up to the amount owed by the public office from those funds lawfully payable and due to the public office.

The public office should contact the Auditor of State's Finance Department to make arrangements to pay delinquent balances prior to certification.

#### **ORDINANCE NO. 111-21**

AN ORDINANCE AMENDING ORDINANCE NO. 95-21, PASSED JUNE 14, 2021 RELATIVE TO THE AGREEMENT WITH AMERICAN STRUCTUREPOINT, INC. FOR THE WEST SMITH ROAD, PHASE 4 PROJECT.

- WHEREAS: Ordinance No. 95-21, passed June 14, 2021, authorized an Agreement with American Structurepoint, Inc. to provide Right-of-Way Acquisition Services for the West Smith Road, Phase 4 Project (Job #1025); and
- WHEREAS: Ordinance No. 95-21, passed June 14, 2021 failed to relate that Ordinance No. 95-21 is an Amendment to the Agreement authorized by Ord. 159-20, passed September 14, 2020 authorizing a contract with American Structurepoint, Inc. to provide design services for the West Smith Road, Phase 4 Project.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:

- SEC. 1: That Ordinance No. 95-21, passed June 14, 2021 is hereby amended to state that it is authorizing the Amendment to the Agreement previously authorized in Ordinance No. 159-20, passed September 14, 2020 with American Structurepoint, Inc., for the West Smith Road, Phase 4 Project.
- SEC. 3: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law.
- **SEC. 4:** That this Ordinance shall be in full force and effect at the earliest period allowed by law.

#### ORDINANCE NO. 112-21

AN ORDINANCE PROPOSING AND PROVIDING FOR SUBMISSION TO THE ELECTORS OF THE CITY OF MEDINA, OHIO, AT A GENERAL ELECTION TO BE HELD NOVEMBER 2, 2021, AN AMENDMENT TO THE CHARTER OF THE CITY OF MEDINA, OHIO, INVOLVING ARTICLE V, SECTIONS 1 AND 3, AND ARTICLE III, SECTION 12, RELATIVE TO THE POSITION OF THE DIRECTOR OF FINANCE.

WHEREAS: Article V, Section 1, involving general provisions presently reads as follows:

Section 1. General Provisions. Initially, the City shall have a Law Department, a Finance Department, a Service Department, and a Safety Department; and the Council shall provide by ordinance for the organization and duties thereof. The City shall also have a City Planning Commission and a Board of Appeals. The Council may by ordinance establish additional departments and commissions, or divisions thereof, and provide for such boards, officers, and employees as it may deem necessary. With the exception of those herein set forth, the Council may combine or abolish any department, division, board, commission, nonelective office, or job classification; and may authorize one person to serve in any capacity in two or more departments, divisions, boards, or commissions. With the exception of the head of the Finance Department, the heads of all departments shall be appointed by the Mayor, subject to confirmation of Council.

WHEREAS: Article V, Section 3, involving the Director of Finance of the Charter of the City of Medina, Ohio, presently reads as follows:

# Section 3. Director of Finance.

- (a) <u>Term</u>. The Director of Finance shall be elected for a term of four (4) years, assume his office on the first day of January following his elections, and serve until his successor is elected and qualified.
- (b) Qualification. The Director of Finance shall, on the date of his election and during his term in office, be and continue to be a resident of the City and a qualified elector thereof. He shall be 1) a licensed certified public accountant, or 2) have a four year degree or higher, in accounting or finance with a minimum of two years of experience in government related accounting and/or auditing. He shall not hold any other public

office or public employment except as otherwise provided in this Charter or by ordinance, and that of Notary Public or of membership in the State Militia or Reserve Corps of the United States. (Amended 11-8-16.)

- (c) <u>Duties</u>. The Director of Finance shall be the head of the Finance Department and the fiscal officer of the City. He shall serve the Mayor and the Council as financial advisor in connection with Municipal affairs. The Director of Finance shall examine all payrolls, bills and other claims against the City and shall issue no warrant unless he shall find that the claim is in proper form, correctly computed and duly approved, and that it is due and payable, and that an appropriation has been made therefor; and he shall perform such other duties consistent with his office as Mayor or the Council may request. Council may cause the records of the Director of Finance to be audited independently in any year.
- Vacancy in the Office of the Director of Finance. In case of the death, disqualification, removal or resignation of the Director of Finance, his successor shall be appointed by a majority of the members elected to Council shall immediately appoint an interim Director of Finance who shall have all of the duties, rights and powers of the Director of Finance until an appointment is made. If the vacancy of the position of Director of Finance is not filled within ninety (90) days, the Mayor shall fill it by appointment within thirty (30) days thereafter. Such appointee shall hold office until the next regular municipal election occurring more than seventy-five (75) days after such vacancy occurs unless the term of such office expires at the end of the year in which such vacancy occurs. At such next regular municipal election, there shall be elected in the manner provided in this Charter, a person to fill the unexpired term caused by such vacancy. The person chosen at such election shall immediately, upon his qualification, succeed such appointee and shall serve during the remainder of the unexpired term or until his successor is elected and qualified. (Amended 11-2-04.)

WHEREAS: Article III, Section 12, involving salaries and bonds of the Charter of the City of Medina, Ohio, presently reads as follows:

Section 12. Salaries and Bonds. The Council shall fix the salary or compensation of each officer, employee and member of any board or commission of the City. Any such person may be required by the Council, from time to time, to furnish a bond or bonds for the faithful performance of his duties; and the Council may provide that the premium for any such bond shall be paid by the City. The compensation of the Mayor, Director of Finance and of each member of the Council shall not be changed except it be fixed at least thirty days before the time for filing nominating petitions for the terms beginning on the next succeeding first day of January, and shall not thereafter be changed in respect of any such terms

or any part thereof. The compensation of each officer, employee and member of a board or commission of the City shall be fixed by the Council, and, subject to the power of the Council to provide otherwise by ordinance or resolution, may be changed at any time in its discretion. (Approved by voters November 5, 1986.)

WHEREAS: Upon the recommendation of the Charter Review Commission, this Council has determined to place the question of an amendment to Article V, Sections 1 and 3, and Article III, Section 12, on the November 2, 2021, ballot.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO, TWO-THIRDS OF THE MEMBERS ELECTED THERETO CONCURRING:

- SEC. 1: That the question of the amendment to Article V, Sections 1 and 3, and the amendment of Article III, Section 12, of the Charter of the City of Medina, Ohio, shall be submitted to a vote of the qualified electors of the City of Medina at the general election to be held on November 2, 2021, at the regular places of voting in the City of Medina.
- SEC. 2: That the question of the amendment of Article V, Section 1, of the City of Medina, Ohio, Charter, as amended, would, if approved by said voters, read as follows:

# ARTICLE V ADMINISTRATIVE DEPARTMENTS AND COMMISSIONS

Section 1. General Provisions. Initially, the City shall have a Law Department, a Finance Department, a Service Department, and a Safety Department; and the Council shall provide by ordinance for the organization and duties thereof. The City shall also have a City Planning Commission and a Board of Appeals. The Council may by ordinance establish additional departments and commissions, or divisions thereof, and provide for such boards, officers, and employees as it may deem necessary. With the exception of those herein set forth, the Council may combine or abolish any department, division, board, commission, non-elective office, or job classification; and may authorize one person to serve in any capacity in two or more departments, divisions, boards, or commissions. The heads of all departments shall be appointed by the Mayor, subject to confirmation of Council.

SEC. 3: That the question of the amendment of Article V, Section 3, of the City of Medina Charter, as amended, would, if approved by said voters, read as follows:

# ARTICLE V ADMINISTRATIVE DEPARTMENTS AND COMMISSIONS

#### Section 3. Director of Finance.

- (a) <u>Term.</u> Effective January 1, 2026, the Director of Finance shall be appointed by the Mayor subject to the confirmation of the Medina City Council. The Director of Finance shall be subject to removal by an affirmative vote of two-thirds of the members of the Medina City Council. Effective January 21, 2026, the Director of Finance shall serve for a term that will be concurrent with the term of the Mayor of the City of Medina.
- (b) <u>Qualifications</u>. The Director of Finance shall, on the date of his appointment and during his term of office, be and continue to be a resident of the City of Medina and qualified elector thereof. He shall be 1) a licensed certified public accountant or 2) have a four-year degree or higher in accounting or finance with a minimum of two years of experience in government-related accounting and/or auditing. He shall not hold any other public office or public employment except as otherwise provided in this Charter or by ordinance and that of Notary Public or of membership in the State Militia or Reserve Corps of the United States.
- (c) <u>Duties</u>. The Director of Finance shall be the head of the Finance Department and the fiscal officer of the City. The Director of Finance shall monitor financial performance, prepare reports, assemble budgeting documents, and provide other related analysis and reports as requested by the Mayor and Council. The Director of Finance shall examine all payrolls, bills, and other claims against the City and shall issue no warrant unless he shall find that the claim is in proper form, correctly computed, and duly approved, and that it is due and payable, and that an appropriation has been made therefor, and he shall perform such other duties consistent with his office as the Mayor and the Council may request. Council may cause the records of the Director of Finance to be audited independent in any given year.
- SEC. 4: That the question of amendment to Article III, Section 12, of the Charter of the City of Medina, Ohio, shall be submitted to a vote of the qualified electors of the City of Medina at the general election to be held on November 2, 2021, at the regular places of voting in the City. The Charter, as amended, would, if approved by said voters, read as follows:

# ARTICLE III THE COUNCIL

Section 12. Salaries and Bonds. The Council shall fix the salary or compensation of each officer, employee and member of any board or

commission of the City. Any such person may be required by the Council, from time to time, to furnish a bond or bonds for the faithful performance of his duties; and the Council may provide that the premium for any such bond shall be paid by the City. The compensation of the Mayor and of each member of the Council shall not be changed except it be fixed at least thirty days before the time for filing nominating petitions for the terms beginning on the next succeeding first day of January, and shall not thereafter be changed in respect of any such terms or any part thereof. The compensation of each officer, employee and member of a board or commission of the City shall be fixed by the Council, and subject to the power of the Council to provide otherwise by ordinance or resolution, may be changed at any time in its discretion.

SEC. 5: That the ballot for said election shall, at the top thereof, be entitled, "City Charter Amendment Ballot," and the question to be submitted on said ballot shall be in words as follows:

"Shall Article V, Sections 1 and 3, and Article III, Section 12, of the Charter of the City of Medina, Ohio, be amended so as to eliminate the elected office of the Director of Finance and provide for the appointment of the Director of Finance by the Mayor, subject to the confirmation of the Medina City Council, and to provide for the qualifications, powers, duties, and functions of the appointed Director of Finance?"

- SEC. 6: That the Board of Elections shall publish the full text of the proposed Charter amendments as set forth hereinabove, once a week, for not less than two consecutive weeks in the *Medina Gazette*, with the first publication being at least fifteen days prior to the election hereinbefore provided, all in accordance with Section 9 of Article XVIII of the Ohio Constitution and R.C. 731.211.
- SEC. 7: That this Ordinance shall be in full force and effect at the earliest period allowed by law.
