# 3. <u>23-207-10/23 – Grant Application – Bullet Proof Vest Partnership – Police</u>

Chief Kinney stated this is their annual grant for the vests, there is a 50% match, requesting permission to apply and to accept the grant. Emergency is needed due to time restraints with the grant. Mr. Shields moved to approve with the emergency clause, seconded by Mr. Simpson. Motion passed 6-0.

### 4. <u>23-208-10/23 – Expenditure – CHIP Rehab – 137 Oakleigh Dr.</u>

Andrew Dutton stated this is for \$46,085 and emergency is needed to pay contractor. Mr. Shields moved to approve with the emergency clause, seconded by Mr. Simpson. Motion passed 6-0.

Andrew Dutton stated this is for \$71,925 and emergency is needed to pay contractor. Mr. Shields moved to approve with the emergency clause, seconded by Mr. Simpson. Motion passed 6-0.

6. <u>23-210-10/23 – Amend Ord. 132-23 – CHIP Rehab – 1495 McKinley Ave.</u>

Andrew Dutton stated this is for \$66,670 and emergency is needed to pay contractor. Mr. Shields moved to approve with the emergency clause, seconded by Mr. Simpson. Motion passed 6-0.

# 7. <u>23-211-10/23 – Amend 161.13 – Income Tax Allocation</u>

Keith Dirham stated this was approved at the last budget meeting. Changes are the Police Fund is reduced 3.5%, the General Fund is increased .5%, General Purpose Capital is increased 1%, Electronic Technology Capital is increased 1% and Unanticipated Capital Contingency Fund is increased 1%. Mr. Shields moved to approve, seconded by Mr. Simpson. Motion passed 6-0.

## 8. <u>23-212-10/23 – Amend Code Ch. 162 – Income Tax Ordinance – HB 33</u>

Keith stated he received this from RITA and we don't have a choice it's based on something the state passed and we have to do this. Final language on the ordinance is not together yet. \*\*\*on hold

### 9. <u>23-213-10/23 – Increase Exp. – CHIP Rehab – 30 Circle Dr.</u>

Andrew stated they found additional mold in the basement and are asking for an increase in the P.O. to a total of \$44,789.08. Emergency is requested to pay contractor. Mr. Shields moved to approve with the emergency clause, seconded by Mr. Simpson. Motion passed 6-0.

### 10. <u>23-214-10/23 – Amend Ord. 50-22 – Pavilion Rental Fees – Parks Dept.</u>

Jansen Wehrley stated this is to request create a new fee for the uptown park under our additional fees. Trying to reduce the number of spider boxes that they have to put out every weekend for the various events we have. Need to repeal all these ordinances and get all fees on one page and adopt that. Mr. Shields moved to approve, seconded by Mr. Simpson. Motion passed 6-0.

### 11. <u>23-215-10/23 – Management Agreement for City of Medina Airport</u>

Mr. Huber stated they worked out a new agreement for R. Waldron Entity to take over management at the airport effective November 1<sup>st</sup>, 2023. \*\*\* Hold for next meeting.
