- **SEC. 4:** That this Ordinance shall be considered an emergency measure necessary for the immediate preservation of the public peace, health and safety, and for the further reason as these salaries must be in place before the filing deadline date for the November, 2021 election; wherefore, this Ordinance shall be in full force and effect immediately upon its passage and signature by the Mayor.
