All vendors must provide their own tent and all tables & chairs, but it is possible to display as a free-roaming vendor without a tent. All tents must have 25 lb. weights per leg. Due to limited supply, there is no water or electricity available. It is each vendor's responsibility to obtain all necessary vendor or health department licenses prior to event and provide a copy of license with this registration form. These must be submitted no later than March 22, 2024. The vendor is responsible for all decoration and set up of items and information. In addition, this is a family oriented event, and the Vendor agrees to display only material and products that are considered appropriate for all ages. The vendor agrees to keep all commentary and printed information free of vulgar language or innuendo, and to conduct themselves in a professional manner at all times.

I covenant and agree to indemnify and hold harmless the City of Medina, its respective employees, officers, and agents from all liability, loss, and expense, including but not limited to damages, legal expenses and costs of defense in any manner arising as a result of my use of water provided by the City of Medina.*
