Dennis Hanwell, Mayor:

- A. The Medina Community Band Concerts began this past Friday, June 7th at 8:30 p.m. The concerts will continue each Friday evening in June and July with the exception of the July 5th concert will be on July fourth and all concerts are weather permitting.
- B. The third annual Juneteenth celebration will take place this Saturday, June 15th from 10 a.m.- 3 p.m. Thankful for the sponsors and donators to permit the event to be held free of charge on our public square. There will be a variety of cultural music.

Keith Dirham, Finance Director, Keith stated there is an item on the agenda and he will talk about it when they get there.

Kimberly Marshall, Economic Development Director, Kimberly stated the next round of ribbon cuttings events are scheduled for Friday, June 14th. The first one is at 10 a.m. – Romancing the Walls located at 443 W. Liberty, 11 a.m. – 25th anniversary for the Gardner's Cottage located at 226 S. Court St., ground breaking for Acme Grocery Store 12:30 a.m. located at 1225 S. Court St., and last event of the day at 2 p.m. Reform and Restore Pilates located at 799 N. Court St. Suite #8.

There were a lot of questions about the 426 W. Liberty site which is the former Sunoco property. We have not heard back whether their grant has been approved, if not then they will apply again if the state still offers that program.

They have all their responses back from the companies that they have their job creation grants and have received responses back from RITA and will be starting our Job Creation Grant monitoring meetings with those companies and then bring report back to council.

Greg Huber, Law Department, had no report.

Chief Kinney, Police Department had no report.

Chief Walters, Fire Department, was absent.

Jansen Wehrley, Parks and Recreation Director, stated the Memorial Pool is open from 11 a.m. to 7 p.m. 7 days a week. Splashpads are on at Greenwood Park 11 a.m. – 8 p.m., and Ray Mellert Park from 12 p.m. - 8 p.m. The parks have been pretty busy lately with the MIST tournament and the Sting Shootout, and a softball tournament coming up. Party in the Park series started last week, it is put on by the Rec Center and sponsored by the Cleveland Clinic Medina Hospital and this Thursday they will be a pool party at Memorial Park from 6 p.m. to 8 p.m. with a DJ.

Tuesday, June 18th is the Touch a Truck at the Medina Rec 11 a.m. to 1 p.m.

Project at Spring Grove Cemetery removing the roof on the Mausoleum started today. Friends of

the Cemetery is assisting and funding with this project.

Dan Gladish, Building Official, presented an update for the first six months of the year;

The Building Department is extremely busy with no sign of a slowdown. There are currently six large commercial projects under construction at this time, they include three new buildings: Meijer Grocery Store – Acme Fresh Market – Medina County Career Centers – which consists of two new construction trades classrooms and shops. The existing recently remodel construction trades classroom and shop will be converted for the electrical trades. There are three new large building additions which include: Drug Mart Distribution – Owens Corning Warehouse – Tru-Fit Manufacturing on Lake Road which includes new production and warehouse space. These six-projects equal 590,000 sq. ft. of new floor space with construction/investment cost of \$48 million dollars.

We also have three additional large commercial projects under going plan review at this time. We continue to see investment and growth along North Court the projects include: two new restaurants, Aladdin's Grille and Wing Stop. Also, on North Court, the unoccupied Loan Max Building recently sold to a local business owner with plans for a remodel and expansion of his business. This is the building adjacent to, and was owned by the Speedway Gas Station. They at one time planned an expansion of the gas station.

Residential construction throughout the city includes: two new homes and approximately 260 active residential permits for various types of construction projects.

Jonathan Renninger, the new Property Maintenance/Zoning Inspector started working for the city today. He fills the vacancy that they had for the past two months.

Nino Piccoli, Service Director, stated they have received ongoing calls with questions and concerns about the city deer. The city has to date picked up 38 deer carcasses and that number will just increase by fall, it will double. There is a plan and it will be discussed more as summer goes through. This Thursday our City Engineer will be celebrating a milestone birthday. Happy Birthday Pat Patton!

Patrick Patton, City Engineer, updated information on the courthouse renovation project. Received statement of qualifications from construction managers interested in the project. Review committee met last week and narrowed it down to two firms.

Andrew Dutton, Planning and Community Development Director, had no report.

Chief Kinney stated this is their annual maintenance agreement for their main computer system they use in the Police Department. The roll was called and Ordinance/Resolution No. 108-24 passed by the yea votes of J. Hazeltine, P. Rose, J. Shields, D. Simpson, J. Coyne, N. DiSalvo, and R. Haire.

Ord. 109-24

An Ordinance of the Council of the City of Medina, Ohio, certifying that when a municipal obligation was incurred sums were lawfully appropriated in the funds to satisfy the obligation and sufficient sums currently exist to satisfy this obligation. Mr. Shields moved for the adoption of Ordinance/Resolution No. 109-24, seconded by Mr. Simpson. Mr. Shields moved that the emergency clause be added to Ordinance/Resolution No. 109-24, seconded by Mr. Simpson. Mr. Dirham stated there have been a lot of rail breaks on the city owned railroad. This is pay to the vendor that fixes those. Emergency is needed due to work being completed. The roll was called on adding the emergency clause and was approved by the yea votes of P. Rose, J. Shields, D. Simpson, J. Coyne, N. DiSalvo, R. Haire, and J. Hazeltine. The roll was called and Ordinance/Resolution No. 109-24 passed by the yea votes of J. Shields, D. Simpson, J. Coyne, N. DiSalvo, R. Haire, J. Hazeltine, and P. Rose

Ord. 110-24

An Ordinance amending Ordinance No. 47-24, passed February 26, 2024 relative to geotechnical services for the Prospect Street Bridge Replacement Project. Mr. Shields moved for the adoption of Ordinance/Resolution No. 110-24, seconded by Mr. Simpson. Patrick stated they received about \$1.8 million dollars from ODOT for the construction of the bridge replacement. ODOT in addition to that is funding \$200,000 toward the design and the city is responsible for Geotechnical Services. They added some light to the project limits which resulted in increased cost. The roll was called and Ordinance/Resolution No. 110-24 passed by the yea votes of D. Simpson, J. Coyne, N. DiSalvo, R. Haire, J. Hazeltine, P. Rose, and J. Shields.

Ord. 111-24

An Ordinance authorizing the Mayor to accept the modifications to the Medina County Thoroughfare Plan Proposed Project List as recommended by the Medina Area Transportation Task Force. Mr. Shields moved for the adoption of Ordinance/Resolution No. 111-24, seconded by Mr. Simpson. Patrick stated this task force was formed and ultimately produced a report that included several different recommendations from the area which included the city, the four townships and the county for future transportation improvement projects. There is a project they would like to complete near SR3 and SR162 and in doing that would make it impossible for two of their recommended projects to occur. They unanimously voted to remove the two from the 2001 report. The roll was called and Ordinance/Resolution No. 111-24 passed by the yea votes of J. Coyne, N. DiSalvo, R. Haire, J. Hazeltine, P. Rose, J. Shields, and D. Simpson.

Res. 112-24

A Resolution requesting the Medina County Auditor to certify the total current tax valuation and the dollar amount of revenue that would be generated for the renewal of 3.2 mills for the operation of an Ambulance and Emergency Medical Service. Mr. Shields moved for the adoption of Ordinance/Resolution No. 112-24, seconded by Mr. Simpson. Mr. Dirham stated this is the first step of the process to put this renewal on the ballot this fall. Just asking for a renewal of the existing levy so there will be no change there. The roll was called and Ordinance/Resolution No. 112-24 passed by the yea votes of R. Haire, J. Hazeltine, P. Rose, J. Shields, D. Simpson, J. Coyne, and N. DiSalvo.

RESOLUTION NO. 115-24

A RESOLUTION DECLARING IT NECESSARY TO LEVY A RENEWAL OF AN EXISTING TAX OF 3.2 MILLS IN EXCESS OF THE TEN MILL LIMITATION FOR THE OPERATION OF AN AMBULANCE AND EMERGENCY MEDICAL SERVICE.

- WHEREAS: In accordance with Section 5705.03 of the Ohio Revised Code, the City adopted Resolution No. 112-24, passed June 10, 2024, requesting the Medina County Auditor certify the total current tax valuation and the dollar amount of revenue that would be generated for the renewal of 3.2 mills for the operation of an ambulance and emergency medical service; and
- WHEREAS: On June 11, 2024, the Medina County Auditor provided the City with the "Certificate of Estimated Property Tax Revenue" for the renewal of 3.2 mills for the operation of an ambulance and emergency medical service. A copy of the form is marked Exhibit A, attached hereto and incorporated herein.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO, TWO-THIRDS OF ALL MEMBERS ELECTED THERETO CONCURRING:

- SEC. 1: That it is necessary to levy a renewal levy of an existing tax in excess of the ten mill limitation for the benefit of the City of Medina, Ohio for the purpose of providing and maintaining necessary or desirable equipment, personnel, supplies and paying any and all other costs or expenses incidental to the operation of an ambulance and emergency medical service at a rate not-to-exceed 3.2 mills for each one dollar of valuation which amounts to seventy-one dollars (\$71.00) for each one hundred thousand dollars (\$100,000.00) of valuation for a period of five (5) years, commencing in 2025, first due in calendar year 2026, as estimated by the Medina County Auditor in Exhibit A, attached hereto and incorporated herein.
- SEC. 2: That the property tax revenue that will be produced by the stated millage, assuming the taxable value of the subdivision remains constant throughout the life of the levy, is calculated to be \$1,796,000 per year.
- SEC. 3: That the total taxable value of the subdivision used in calculating the estimated property tax revenue is \$850,074,140.
- SEC. 4: That the levy be placed upon the tax lists of the current tax year for collection in compliance with the provisions of Section 5705.19(U), if a majority of the electors voting thereon vote in favor thereof.
- SEC. 5: That the date of election for placement of the question on the ballot is November 5, 2024.

SEC. 6:	That the ballot measure shall be submitted to the entire territory of the City of Medina.			
SEC. 7:	That the tax year in which the tax will first be levied is 2025 and the calendar year in which the tax will first be collected is 2026.			
SEC. 8:	That the City of Medina is a city located entirely within Medina County, Ohio.			
SEC. 9:	That the Clerk of Council of the City of Medina, Ohio, be and she is hereby directed to certify a copy of this Resolution to the Board of Elections, Medina County, Ohio, prior to August 7, 2024, and notify the Board of Elections to cause notice of election on the question of levying the tax to be given as required by law.			
SEC. 10:	That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law.			
SEC. 11:	That this Resolution shall be in full force and effect at the earliest period allowed by law.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:

- SEC. 1: That Section 115.01(a) of the codified ordinances of the City of Medina, Ohio shall be amended to read as follows:

ARTICLE I

This written agreement will become effective on the date of execution of same, and will remain in full force and effect upon the death of the service dog that is to be purchased pursuant to this agreement or unless this agreement is otherwise terminated.

ARTICLE II

The School Board will provide to the City a sum of Twenty-four Thousand Four Hundred Ninety-two Dollars (\$24,492) in monies to purchase a police service dog for utilization at Medina City Schools and primarily at the Medina City High School. It is anticipated that the Twenty-four Thousand Four Hundred Ninety-two Dollars (\$24,492) amount shall be secured pursuant to grant funding. This dog will be trained to provide bomb and firearms detection services, as well as mental health support. The police service dog will be owned by the City and will be under the control and supervision of the Medina City Police Department and the Medina City Police SRO.

ARTICLE III

Monies from the Twenty-four Thousand Four Hundred Ninety-two Dollars (\$24,492) amount shall be utilized by the City to purchase and train the service dog and to outfit a Medina City Police Department vehicle for care and transport of the police service dog.

ARTICLE IV

The Medina City Police Department, through its SRO, agrees to devote time, expertise, and effort to the performance of primary services as outlined herein; it is understood as between the parties that the Medina City Police Department may make use of the police service dog or other services as deemed necessary for situations or individuals who may not be a party to this agreement during the life of this agreement.

ARTICLE V

The Medina City Police Department agrees to supply all food, board, and maintenance for the police service dog that is utilized pursuant to terms of this agreement. The Medina City Police Department will supply all tools and instruments required to perform the service as contracted for pursuant to the terms of this agreement. The Medina City Police Department

agrees to assume sole and complete responsibility for all injuries that may be sustained by either the police service dog or others, which may occur during the use of the police service dog. The Medina City Police Department shall maintain a liability insurance policy that insures the service dog and the use of the service dog. Each party to this agreement shall be responsible for its own negligence or the negligence of its own agents and/or employees.

The Medina City Police Department will be providing a police vehicle for transport of the police service dog and will pay for training for the Medina City Police Department SRO as the police service dog's handler.

ARTICLE VI

The Medina City Police Department will ensure that all Medina City School Board policies are followed; the Medina City School Board policies are attached and set forth on the Police Dog Memo of Understanding, which is attached to this agreement and incorporated herein.

ARTICLE VII

The police service dog shall be trained to possess the proper drives and characteristics in the following areas: area search, article search, building search, obedience work, bomb and firearms detection, and shall be trained as an animal useful for mental health support.

ARTICLE VIII

This agreement shall terminate upon the death of the chosen police service dog or upon one hundred eighty (180) days' written notice by either party to this agreement.

IN WITNESS WHEREOF, the parties have caused this agreement to be executed by their duly authorized officer, intending to be legally bound hereby.

If a person for whom a hearing is to be conducted under division (a) of this section fails to appear at the scheduled hearing and fails to submit evidence in accordance with such division, the hearing examiner, if he or she determines, from a preponderance of the evidence and testimony presented at the hearing, that the person committed the parking infraction, shall enter a default judgment against the person and require the person to pay the appropriate fine and any additional penalties, fees and costs. A default judgment entered under this division shall be entered in the records of the Parking Violations Bureau.

ORDINANCE NO. 129-24

AN ORDINANCE AMENDING SECTION 1 OF SECTION 31.13 OF THE SALARIES AND BENEFITS CODE OF THE CITY OF MEDINA, OHIO RELATIVE TO VACATION FOR EXPERIENCED HIRES.

WHEREAS: Section 31.13, Section 1 of the Salaries and Benefits Code of the City of Medina, Ohio presently reads as follows relating to Vacation:

SECTION 31.13 VACATION

- <u>Section 1.</u> Effective December 1, 2020, each full-time employee shall earn and be entitled to paid vacation in accordance with the following schedule:
 - A. An employee with less than five (5) years of service shall earn vacation with pay at the rate of 3.077 hours per pay period with a maximum earning of two (2) basic work weeks, and may carry over a maximum of 160 hours of earned vacation.
 - B. An employee with five (5) years, but less than eleven (11) years of service shall earn vacation with pay at the rate of 4.615 hours per pay period with a maximum earning of three (3) basic work weeks, and may carry over a maximum of 240 hours of earned vacation.
 - C. An employee with eleven (11) years, but less than twenty (20) years of service, shall earn vacation with pay at the rate of 6.154 hours per pay period (with a maximum earning of four (4) basic work weeks, and may carry over a maximum of 320 hours of earned vacation.
 - D. An employee with twenty (20) or more years of service shall earn vacation with pay at the rate of 7.692 hours per pay period with a maximum earning of five (5) basic work weeks, and may carry over a maximum of 400 hours of earned vacation.
 - E. Employees will not be permitted to carry over vacation into the succeeding calendar year beyond the carryover limits set forth above in this section, in paragraphs A-D.
 - F. For employees on a leave of absence, lay-off, or a period of termination service time will not be accumulated during such leave of absence, lay-off, or period of employment termination.
 - G. <u>Credited Service.</u> For all employees hired after January 1, 1992 only service as a full-time employee of the City of Medina will be credited for purposes of vacation eligibility.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:

SEC. 1: That Section 31.13, Section 1 of the Salaries and Benefits Code of the City of Medina, Ohio shall be amended to read as follows pertaining to Vacation, with the addition of NEW sections H, I and J as follows:

SECTION 31.13 VACATION

- H. Subject to the discretion of the Board of Control, a new hire with significant relevant experience (generally 5-10 years) shall earn vacation time as follows:
 - 1. The new employee shall be granted two (2) weeks vacation upon employment.
 - 2. Such employees shall not accrue vacation for their first year of employment.
 - 3. Upon completing one (1) year of service with the City, such employees shall begin accruing vacation in accordance with sections A through G.
 - 4. An employee hired under this section whose employment with the city is terminated within one (1) year of hire date shall repay the City for any vacation time used that would not have been earned at the normal accrual rate and shall not be eligible for vacation benefits for employment termination under Section 3.
- I. Subject to the discretion of the Board of Control, a new hire with substantial relevant experience (generally ten or more years) shall earn vacation time as follows:
 - 1. The new employee shall be granted three (3) weeks vacation upon employment.
 - 2. Such employees shall not accrue vacation for their first year of employment.
 - 3. Such employees from their one (1) year anniversary with the City through ten (10) years with the City shall earn vacation with pay at the rate of 4.615 hours per pay period with a maximum earning of three (3) basic work weeks, and may carry over a maximum of 240 hours of earned vacation.
 - 4. Upon completion of eleven (11) years of service with the City, such employees shall earn vacation in accordance with Sections C through G.
 - 5. An employee hired under this section whose employment with the City is terminated within one (1) year of hire date shall repay the City for any vacation time used that would not have been earned at the normal accrual rate and shall not be eligible for vacation benefits for employment termination under Section 3.
- J. For employees hired after July 1, 2022, the Board of Control shall have the discretion to apply either of the above sections to them as determined by the Board.
