AN ORDINANCE AMENDING ORDINANCE NO. 108-23, PASSED AUGUST 28, 2023, AUTHORIZING THE MAYOR TO EXECUTE AN AMENDMENT TO LEASE AGREEMENT BETWEEN THE MEDINA COUNTY BOARD OF COMMISSIONERS AND THE CITY OF MEDINA FOR THE LEASE OF A PORTION OF THE MEDINA COUNTY COURTHOUSE COMPLEX KNOWN AS THE 1969 COURTHOUSE.

AMENDMENT TO LEASE AGREEMENT

This "Amendment" is made and entered into as of this 25 day of ______, 2024, by and between THE BOARD OF COUNTY COMMISSIONERS, MEDINA COUNTY, OHIO, (referred to as the "County"), and the CITY OF MEDINA, OHIO (referred to as the "City").

RECITALS:

WHEREAS, the Lease Agreement executed by the County on October 3, 2023, and executed by the City on September 28, 2023, is hereby amended as follows:

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

2.1 Lease Term.

(a) The initial term ("Initial Term") of this Lease shall be for thirty-three (33) years commencing on July 1, 2024, with the exception of charges for security costs, which shall be described hereinafter in this Amendment to Lease Agreement. The parties agree that the County will invoice the City quarterly for lease-related charges.

2.2 Rent, Security Cost and Casualty Insurance Cost.

- 2.2.2 (a) Security Cost. Due to the need for a shared security entry point for the 1969 Courthouse and the 2023 Courthouse, the City shall pay the County twenty percent (20%) of the cost for security located at the security checkpoint area in the 2023 Courthouse. The security staffing configuration at the security checkpoint area currently consists of two deputies and one sergeant, and the City's current annual share of the cost of this configuration is estimated at Seventy Thousand Dollars (\$70,000). The City shall be responsible for paying the cost of security upon the City's occupancy and use of the 1969 Courthouse for Medina Municipal Court operations. Occupancy and use of the 1969 Courthouse for Medina Municipal Court begin to carry out their day to day job functions at the Premises regardless of whether the renovations of the Premises have been completed. The parties hereto agree that in exchange for deferring security costs until the City actually occupies and uses the 1969 Courthouse for Medina Municipal Court operations, the City will permit the County to retain possession of the existing boilers located in the 1969 Courthouse if in fact new boilers are installed during renovation of the 1969 Courthouse.
- (b) Any change the County makes in the configuration and cost of checkpoint security shall be done in consultation with the City, and the cost adjusted accordingly. The City shall provide separate security in a form approved by the County at the City's own expense for any events or use of the process beyond the operational hours of the County Court.

(c) The parties hereto agree that the Medina Municipal Court staff will use the same staff entrance as the Medina County Common Pleas Court staff. If the Medina Municipal Court decides or creates a separate employee entrance, both parties agree that the City will be responsible for one hundred percent (100%) of the security costs of the newly created employee entrance for Medina Municipal Court staff members. Any such separate entrance must be approved by the County before it may be used. The Medina County Sheriff shall control the security for any and all entrances to the 1969 Courthouse.

The parties agree that all of the remaining terms of the Lease Agreement originally entered into between the parties on October 3, 2023, shall remain in full force and effect.
