NOTICE OF BID

Sealed bid proposals will be received by the Mayor of the City of Medina, Ohio in his office at 132 N. Elmwood Avenue, Medina, Ohio 44256 until 10:00 AM local time on Wednesday, September 21, 2022 for the furnishing of all labor, tools, materials, equipment and supervision necessary for the project known as the "WEST SMITH ROAD IMPROVEMENTS", City of Medina Project Number 1025, at which time bids will be publicly opened and read. Bids must be submitted on the forms provided by the City and placed in a sealed envelope with the name of the Project, the name of the bidder and the bid date and time clearly marked on it.

The contract documents, including plans and specifications, are available electronically (at no cost) from the Engineer – American Structurepoint, 600 Superior Avenue East, Suite 2401, Cleveland, Ohio 44114. Bidders are required to register with Robert Chappelle (Email: rchappelle@structurepoint.com; Phone: 216.302.3694) of American Structurepoint to obtain a ShareFile web access to electronically download the project Contract Documents. Paper documents will not be provided.

The Engineer's estimate for the base bid is \$4,255,537.45. The Engineer's estimate for Alternate 1 is \$741,950.00; the estimate for Alternate 2 is \$596,460.00. The City will award one of the two alternates. The final completion date for the project is May 15, 2024. The bidder must submit a completion date with the bid documents.

This project is partially funded by federal funds, as such, contractors must be ODOT pre-qualified at the time of bidding, the time of sale, the time of award, and through the life of the construction contract. An 8% (eight percent) Disadvantaged Business (DBE) goal has been set for this project.

Each bid must be accompanied by a Certified or Cashier's Check, or a bid bond, in the amount of 10 percent of the total amount bid, made payable to the City of Medina, Ohio and the Ohio Department of Transportation as guarantee that, if the bid is accepted, a contract will be entered into with the City within thirty (30) days and its performance secured by a performance bond in the amount of 100 percent of the contract price, and in default thereof, said check or bond will be forfeited to the City of Medina as liquidated damages.

A voluntary pre-bid meeting will be held at 11:00 AM on Friday, September 9, 2022 in the Rotunda of Medina City Hall, 132 N. Elmwood Avenue, Medina, Ohio. Bidders need not be present at this meeting in order to submit a bid.

The City of Medina reserves the right to reject any and all bids and the right to waive any informalities or irregularities in the bidding. Contact the City Engineer at (330) 721-4721 for further information.
