City of Medina Job No. 1089: 2021 Pavement Marking Program

General

This project included the application of pavement markings on City streets within the City of Medina, Ohio. The material for the pavement markings to be installed will include paint and thermoplastic as noted in these contract documents.

Bid Information

The Bid includes the following:

- Application of Pavement Markings (centerline, edge line, channelization line, stop bars, crosswalks, lane arrows, etc.) in accordance with the Ohio Department of Transportation's 2016 Construction and Material Specifications. The pavement markings will be applied at various locations across the entire City; please refer to Section 5.D of these contract documents for further information.
- **o** For a bid to be considered for award, the following items must be submitted:
 - 1. Non-Collusion Affidavit (included within Section #8 of the bid documents)
 - 2. Bidder Information and Experience Record (included within Section #8 of the bid documents).
 - 3. A certified check or cashier's check, or bid bond in the amount of ten percent (10%) of the amount bid (supplied by the Bidder)
 - 4. Bid Proposal (included within Section #8 of the bid documents).

Bid and Award Date

Bids will be accepted until 10:00 A.M. on Friday, August 20, 2021, at which time they will be opened and read publicly. A voluntary pre-bid meeting will be conducted at 11:00 AM on Friday, August 13, 2021 at Medina City Hall, 132 N. Elmwood Avenue, Medina, Ohio. Contractors shall assume that the City will award the bid by Monday, August 23, 2021. The City anticipates issuing a notice to proceed no later than August 27, 2021. The City of Medina reserves the right to reject any and all bids and to waive any informalities or irregularities in the bid.

THE CITY OF MEDINA RESERVES THE RIGHT TO REJECT ANY AND ALL BIDS AND TO WAIVE ANY INFORMALITIES OR IRREGULARITIES IN THE BID.

Completion Date

All pavement markings using Thermoplastic (Unit Price Items #9 through #14) must be completed by no later than <u>October 15, 2021.</u> All pavement markings using Traffic Paint (Unit Price Items #1 through #8) must be completed by no later than <u>November 15, 2021.</u>

Within the bid form, Contractors who so choose may submit a completion earlier than <u>October 15, 2021</u> for Thermoplastic Pavement Markings, and <u>November 15, 2021</u> for Traffic Paint Pavement Markings. Bids with proposed completion dates beyond <u>October 15, 2021</u> for Thermoplastic Pavement Markings, and <u>November 15, 2021</u> for Traffic Paint Pavement Markings. WILL NOT BE CONSIDERED FOR AWARD. Please note, completion date will be a factor during the review and consideration of the bids received. It is possible that a bid other than the lowest bid received may be selected due to a more favorable completion date
