



## MEDINA JULY 4<sup>TH</sup> PARADE REGISTRATION 2025

The City of Medina invites you to participate in our July 4<sup>th</sup> Parade. Each entry in the parade is encouraged to display the American flag.

**The parade will be staged in the Medina High School parking lot on East Union Street (across the street from Sidney Fenn Elementary School).**

There will be assigned rows for all participants and organizations pre-registered for the parade. Row assignments will be given to each participant on the day of the parade. No organization or person will be denied the ability to participate.

The parade will begin **promptly at 4:00 PM** from the High School parking lot, headed south on Spring Grove, then west on Liberty and around the square. The parade will proceed to the Medina Library driveway and will end in the Garfield School parking lot. For safety purposes, no candy or other objects can be thrown from moving vehicles. Additional regulations are specified in the Release Form.

### **To register for the Parade:**

1. Complete one Registration form per group. If you have more than one vehicle or if you want to be in line with another participant, please indicate that on the registration form.
2. **Copy the Release form and have each participant OR parent/legal guardian complete and sign the form.** It is preferred that release forms be turned in prior to participating in the parade but they can be turned in on parade day if necessary. No one will be permitted to be in the parade without first completing the release form. Release forms can be dropped off or mailed to the Mayor's Office or turned in on the day of the parade.
3. **Return the information (Registration forms / Release forms) by Tuesday, July 1, 2025, to the Mayor's Office located at Medina City Hall, 132 N. Elmwood Avenue, Medina, Ohio 44256. Alternatively, you can also scan and e-mail the forms to:**
