Two City of Medina Department Heads Serve in Leadership Positions on State Professional Organization Boards

Economic Development Director Kimberly Marshall is beginning her second term on the Executive Committee of the Ohio Economic Development Association Board. She represents Northeast Ohio and serves on the Executive Committee as Board Secretary. The Executive Committee provides leadership and oversight for the organization, meeting regularly to address key issues and ensure smooth governance. Locally, she chairs the City of Medina Economic Development Committee, the Medina Energy Special Improvement District and the Medina City Development Corporation. She is on the Main Street Medina Board of Directors and the Medina County Convention & Visitors Bureau Board. She is also the founder of Made in Medina County.



Police Chief Edward Kinney, CLEE, currently serves as 2nd Vice-President of the Ohio Association of Chiefs of Police. He will move into 1st Vice President in June of this year and become President of the organization in June of 2026. He also serves on the Legislative Committee and is 2nd Vice President of the Board of Trustees for the Law Enforcement Foundation Inc. He won the Chief Kallai Award for the Continuing Law Enforcement Education, (CLEE) Training Session 26, and that also earned him a seat on the CLEE Board. Chief Kinney is a graduate of the Federal Bureau of Investigation National Academy, Ohio State University Public Safety Leadership Academy, and a Trilogy Award Recipient from the FBI Law Enforcement Executive Leadership Association. Chief Kinney is a member of the International Chiefs of Police Association, the Ohio Chiefs of Police Association, and Leadership Medina County. He serves on the board of directors for the Medina County Children's Board and is the Past President of the Medina County Chiefs Association.

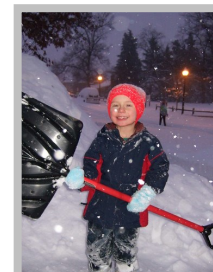

City Ordinance Regarding Snow Removal - Duty to Maintain

Codified Ordinances Section 905.01 through 905.14:
Property owners shall maintain all sidewalks, walkways, stairways, driveways, parking areas, and other similar areas in a proper state of repair free of hazardous defect and free of hazardous condition. The owners and occupiers of abutting lots and lands shall keep the sidewalks in repair and free from snow or any nuisance.
