The provisions of the Ohio Building Code (OBC) section 105.1 state: “Any owner or authorized agent who intends to **construct, enlarge, alter, repair, move, or change the occupancy** of a building or structure, or portion thereof, or to **erect install, enlarge, alter, repair, remove, convert or replace** any electrical, gas, mechanical, plumbing system, other building service equipment, or piping system the installation of which is regulated by this code, or to cause any such work to be done, **shall first make application to the building official and obtain the required approval.**”

OBC Section 106.1- Submittal Documents and OBC Section 107.1- Plan Review Process.

- **Submit three (3) sets of construction documents.**
- **Submit an OBC Application for Plan Approval.**

PROJECT CONTRACTOR LIST

All contractors and subcontractors working in the City of Medina are required to be registered and carry liability insurance in the amount of \$300,000.00, listing the City of Medina as the Certificate Holder. The Certificate of Liability Insurance, as well as any and all applicable state licenses, must accompany Contractor Registration applications. Contractors must register separately for each Ohio Construction Industry Licensing Board category, with the \$100 registration fee paid for each registration.
