## **ORDINANCE NO. 25-17**

AN ORDINANCE AMENDING ORDINANCE NO. 131-12, PASSED JULY 9, 2012 AND AUTHORIZING THE MAYOR TO CONTINUE AND EXTEND THE EMERGENCY MEDICAL SERVICES AGREEMENT BETWEEN MEDINA HOSPITAL, THE CITY OF MEDINA, MEDINA TOWNSHIP AND MONTVILLE TOWNSHIP.

- WHEREAS: Ordinance No. 131-12, passed July 9, 2012 authorized the Mayor to enter into an Emergency Medical Services Agreement between Medina Hospital, the City of Medina, Medina Township and Montville Township to provide emergency medical service for the benefit of the health and welfare of their respective citizens within the geographic boundaries of the Governmental Units; and
- WHEREAS: The Governmental Units desire to extend this agreement for an additional 5 years.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:

- SEC. 1: That the Mayor is hereby authorized and directed to enter into an Amendment to Emergency Medical Services Agreement between Medina Hospital, the City of Medina, Medina Township and Montville Township in accordance with the Amendment marked Exhibit A, attached hereto and made a part hereof.
- SEC. 2: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law.
- SEC. 3: That this Ordinance shall be in full force and effect at the earliest period allowed by law.

## Amendment to Emergency Medical Services Agreement

This Amendment to Emergency Medical Services Agreement ("Amendment") is made an entered into as of the 1st day of January 2017, by and among Medina Hospital ("Hospital") and the City of Medina, an Ohio municipality (the "City"), Medina Township and Montville Township, and amends the Emergency Medical Services Agreement between the parties effective January 1, 2012 (the "Agreement.")

WHEREAS, the Agreement between the parties expired on December 31, 2016, and the parties mutually desire to retroactively re-instate, continue and extend the term of the Agreement,

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

- 1. <u>Effective Date</u>. The Effective Date of this Amendment shall be retroactive to January 1, 2017.
- 2. Article IV. Term and Termination, Section 1 Term. The original Term of the Agreement expired on December 31, 2016, however the parties through their course of dealing have continued to perform under the terms of the Agreement. As the parties desire to retroactively re-instate, continue and extend the Term, Article IV, Section 1. Term, is hereby amended to extend the Initial Term for another five (5) year period (the "Extension Term"), commencing January 1, 2017 and continuing to December 31, 2021, unless earlier terminated as provided in the Agreement.
- 3. All other terms and conditions of the Agreement remain in full force and effect.
