Dennis Hanwell, Mayor, reported the following:

- 1) Outstanding community events very well attended:

 - b. Thanks to Medina County Road Runners for hosting the fifth annual half marathon and 5k race Saturday, May 26th. Over 1,000 attendees from numerous states and surrounding communities. Showcased city very well and supports local non-profits. Sgt. Nate Simpson and Finance Director Keith Dirham both completed the half marathon congratulations.
 - c. Monday, May 28th, Memorial Day Parade. Dave Taylor organized and coordinated the event. Well attended and well participated in. Square and cemetery looked excellent thanks to Jansen's team.
 - d. Monday, May 28th, ceremony to remember Vietnam Veterans at Vietnam Veteran Memorial on Northland Drive, north side of Veterans office. Again, well attended for extreme heat and temperatures yesterday.

Medina City Council May 29th, 2018

Keith Dirham, Finance Director, Mr. Dirham spoke of the events over Memorial Weekend especially seeing Councilman Dennie Simpson speaking at the Encampment over at Spring Grove Cemetery and Councilman Paul Rose dressed up in Civil War garb playing a trumpet.

Greg Huber, Law Director, had no report.

Chief Kinney, Police Department, stated they had a very busy weekend in the Police Department as well, with all the events. The Chief thanked his Specials Unit and the Citizens Police Academy Alumni Association for all they did and stated they couldn't have handled all those events and the associated traffic with it if it wasn't for their assistance.

Kimberly Marshall, Economic Development Director, was absent.

Jonathan Mendel, Planning Community Director, had no report.

Chief Painter, Fire Department, had no report.

Mike Wright, Recreation Center Director, Stated that the Memorial Pool is now open from 7 a.m. to 7 p.m. every day of the week. He thanked the community for coming out and showing their support this weekend. Reminder for anyone that qualifies for the school lunch program that your membership at the outdoor pool is 50% off and so for a family of 5 that would only be \$100 for the summer and day passes would only be \$4. Note to our Senior Silver Sneaker Optimum Prime Members, your Rec membership ID cards can now also be used at the outdoor pool. Next Rec Advisory Board meeting will be Thursday, June 21st at 7:30 a.m. at the Rec Center.

Jansen Wehrley, Parks and Recreation Director, Jansen thanked his staff for all their efforts the last couple of weeks preparing everything for Memorial Day and putting in extra hours to make sure everything was ready. Jansen announced that the Splashpads are open, Fred Greenwood Park is 11 a.m. to 8 p.m. and Ray Mellert Park is 12 p.m. to 8 p.m. weather permitting.

Dan Gladish, Building Official, Stated Carlise Brake and Friction with their 150,000 sq. ft. addition is close to completion and close to starting up its new production lines. Rico Manufacturing's 16,320 sq. ft. addition is half complete. Spray Products, which took over the existing vacant 208,000sq. ft. Valspar building, is expected to start up its first production line this week.

Patrick Patton, City Engineer, gave updates for Rt. 42 stating asphalt paving on the east side of the road has begun, and within the next two to three weeks they will flip traffic and begin the other side. Forest Meadows work should be done this week and he anticipates the road being open next week. Patrick wanted to notify the public of two projects that will affect the traffic for residents and businesses: Construction on the Guilford Blvd. Bridge is expected to start next week and they will be issuing letters to all the residents in the area and some other advertising to get the word out. This construction will require a 63 day closure of Guilford Blvd. south of Smith Rd. East Smith Road between Court and Jefferson is also expected to start within the next couple of weeks.

Medina City Council May 29th, 2018

Nino Piccoli, Service Director, stated that service crews are repairing catch basins all throughout the city that have failed over the winter. The Sanitation crews have started picking up yard waste and will do so until the end of November. The yard waste truck will have a little delay in pick up and we ask for your patience, it doesn't follow directly behind the regular sanitation truck.

High grass letters have been sent out in every ward and with the recent rains some folks have got a little behind in cutting. We have our high grass contractor out mowing the ones that are in violation.

Introduction and Consideration of Ordinances and Resolutions:

Res. 088-18:

A Resolution authorizing the adoption of the 2018 Strategic Plan Update for the City of Medina. Mr. Shields moved for the adoption of Ordinance/Resolution No. 088-18, seconded by Mr. Simpson. Mr. Coyne spoke of the 2018 Strategic Plan and their members being himself as the Committee Chairman, Jim Shields — Council Representative, Mayor Dennis Hanwell — Administrative Representative, Nino Piccoli — Administrative Representative, Allysa Williams — Ward 1 Representative, Clay Benjamin — Ward 2 Representative, Nicole Glatz — Ward 3 Representative, Paul Pfeiffer — Ward 4 Representative, Jim Gerspacher — At-Large Representative and Stanley Sheetz — At-Large Representative alternate, and Kathy Patton our Clerk of Council kept notes and modified the document. Mr. Coyne stated one of the main initiatives that came out of the plan through our discussions was that the committee believed that there should be a council representative that monitors each of the goals in the plan and give updates every quarter to make sure they stay focused. John thanked the committee for their efforts. The roll was called and Ordinance/Resolution No. 088-18 passed by the yea votes of J. Shields, D. Simpson, J. Coyne, B. Lamb, L. Parnell-Cavey, and P. Rose.

Res. 089-18:

A Resolution accepting four (4) donations received from various sponsors to go towards the Medina City Police Department K9 Program. Mr. Shields moved for the adoption of Ordinance/Resolution No. 089-18, seconded by Mr. Simpson. Chief Kinney is requesting authorization to accept these four donations and have those funds allocated to the K9 Program. The roll was called and Ordinance/Resolution No. 089-18 passed by the yea votes of D. Simpson, J. Coyne, B. Lamb, L. Parnell-Cavey, P. Rose, and J. Shields.

Ord. 090-18:

An Ordinance adopting a new Chapter 162 of the Codified Ordinances of the City of Medina, Ohio regarding Municipal Income Tax. Mr. Shields moved for the adoption of Ordinance/Resolution No. 090-18, seconded by Mr. Simpson. Mr. Shields moved that the emergency clause be added to Ordinance/Resolution No. 090-18, seconded by Mr. Simpson. Mr. Dirham states this is in response to state law changes that the state legislator has made and ongoing litigation regarding those changes. Keith thanked the Law Department for all the time they put into this. Mr. Coyne states they corrected the issue of a possible double taxation. Mr. Rose states the only reason he is voting yes for this is because it helps the residents. The roll was called on adding the emergency clause and was approved by the yea votes of B. Lamb, L. Parnell-Cavey, P. Rose, J. Shields, D. Simpson, and J. Coyne. The roll was called and Ordinance/Resolution No. 090-18 passed by the yea votes of J. Coyne, B. Lamb, L. Parnell-Cavey, P. Rose, J. Shields, and D. Simpson.

Ord. 091-18:

An Ordinance authorizing the Mayor to execute a Revocable Use Permit to 226 South Court Street (PPN 028-19B-20-110) to use or occupy a part of the City Right-of-Way an existing enclosed stairwell attached to and abutting the main structure. Mr. Huber explained this revocable use permit applies to the property that involved the building wall that collapsed near the downtown square. In the process of starting the rebuild, the property itself was resurveyed and discovered that the stairwell at the back of the building encroaches on city right-of-way and they are presenting to council a use permit that allows the property to continue the use but also establishes the city right-of-control over that property. Mr. Shields moved for the adoption of Ordinance/Resolution No. 091-18, seconded by Mr. Simpson. The roll was called and Ordinance/Resolution No. 091-18 passed by the yea votes of L. Parnell-Cavey, P. Rose, J. Shields, D. Simpson, J. Coyne, and B. Lamb.

Ord. 092-18:

An Ordinance authorizing the City of Medina to join the Ohio Association of Public Treasurer's Bureau of Worker's Compensation Pool, and authorizing the expenditure to CompManagement to continue to be the City's representative for Bureau of Worker's Compensation matters. Mr. Shields moved for the adoption of Ordinance/Resolution No. 092-18, seconded by Mr. Simpson. Mr. Shields moved that the emergency clause be added to Ordinance/Resolution No. 092-18, seconded by Mr. Simpson. Mr. Dirham stated the history on this is that we've been in a pool with the Ohio Municipal League where our TPA/MCO was CompManagement and OML decided to switch to Care Works and we had no notice of that switch at all. We are asking to switch to The Ohio Association of Public Treasurer's Pool because we will still be with CompManagement at that point. Emergency clause is needed due to open enrollment being in May. The roll was called on adding the emergency clause and was approved by the yea votes of J. Shields, D. Simpson, J. Coyne, B. Lamb, L. Parnell-Cavey, and P. Rose, J. Shields, D. Simpson, J. Coyne, B. Lamb, and L. Parnell-Cavey.

Council Comments:

Laura Parnell-Cavey thanked everyone that joined them at Ray Mellert Park for a community cleanup. Around 20 people showed up and they collected 17 bags of trash. Laura stated she plans on scheduling more in the future.

Councilman Simpson spoke of the Encampment at the Spring Grove Cemetery this weekend and thanked the Mayor, Police Chief, Law Director, Service Dept. and the 8th Ohio Volunteer Infantry along with three of the reenactors. Dennie thanked Jansen and his staff for the caretaking of the cemetery and how good it looked just like all our parks. Dennie extended his gratitude to the Friends of the Cemetery for putting this event on for part of the Medina Bicentennial. Dennie ended with thanking Councilman Paul Rose who spent the entire day in a Civil War uniform sounding the horn every time there was an event getting ready to start throughout the day. Dennie also said that the Marathon was a huge success story for the City of Medina, and he acknowledged Ron Ross and his entire staff in helping organize the marathon. He congratulated his wife for running the first time in this marathon and wished her a Happy Birthday.

At-Large Council Representative Lamb spoke of the Encampment and how well it was organized and how so many people attended that and the Marathon and Farmer's Market. He was told many times how beautiful the square looked.

Rock'n the Court, a music event on South Court Street is on June 9^{th} from 4 p.m. -7 p.m. Come check out the bands, food and other sorts of entertainment.

Weather permitting the Orchard Project planting of the first orchard will be at 5:30 p.m. on Thursday. Planting will take place on the corner of Jefferson and East Liberty.

Bill thanked Laura Parnell-Cavey for the community trash cleanup.

At-Large Council Representative Paul Rose stated Mr. Dennie Simpson deserves a huge accolade, he was the Master of Ceremonies and kept everything running on schedule.

Mr. Rose stated he had the privilege and honor to be in Milan Italy on Liberation Day April 25th and the Beaches of Normandy on May 8th and how it was a very humbling experience for him.

Councilman Shields stated when he thinks of the Mayor's State of the City addresses and he said "What was so special about Medina" I think we just heard everything that is so special about Medina.

Council President John Coyne announced that Wednesday, June 6th is a budget hearing. John stated they have a vacancy on council and June 1st is the deadline for a Ward 3 resident to apply to fill the vacancy by filling out an application and submit it to Kathy Patton.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:

- SEC. 1: That the City owned properties located at 120 N. Court Street (PPN 028-19B-20-138) and 125 E. Liberty Street (PPN 028-19B-20-136) shall be rezoned from C-2, Central Business to P-F, Public Facilities.
- SEC. 2: That the City owned property located at 360 Foundry Street (PPN 028-19A-16-011) shall be rezoned from R-3, High Density Urban Residential to O-C, Open Space Conservation.
- SEC. 3: That the City Engineer is hereby directed to amend the zoning map as necessary to correctly reflect this change in zoning.
- SEC. 4: That a drawing and Zoning Description of rezoning, is attached hereto and incorporated herein.
- SEC. 5: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:

- SEC. 1: That the Mayor is hereby authorized to execute a Revocable Use Permit with Birth Family Limited Partnership IV to use or occupy a 38.25 square foot portion of the North Broadway public right-of-way located adjacent to the east of the Permittee's leased property at 100 Public Square, Permanent Parcel No. 028-19B-20-047, with a business identification sign.
- SEC. 2: That a copy of the Revocable Use Permit is marked Exhibit A, attached hereto and incorporated herein.
- SEC. 3: That the Clerk of Council is hereby directed to file the Revocable Use Permit with the Medina County Recorder.
- SEC. 4: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law.
- SEC. 5: That this Ordinance shall be in full force and effect at the earliest period allowed by law.

REVOCABLE USE PERMIT

Permission is hereby granted to Birch Family Limited Partnership IV ("Permittee") to use or occupy a 38.25 square foot portion of the North Broadway public right-of-way located adjacent to the east of the Permittee's leased property at 100 Public Square (Permanent Parcel #028-19B-20-047) with a business identification sign. The area of encroachment and sign plans are shown on the attached exhibits and legal description.

The granting of this permit shall not be construed as an abridgement or waiver of any rights which the **City of Medina** has in exercising its jurisdictional powers and this permit shall be binding upon the **City of Medina** and the **Permittee**, his/her/its heirs, successors and assigns.

The City of Medina, for any reason and at any time, may order removal of the encroachments that are the subject of this use permit. If for any reason the City of Medina or its duly authorized representative deems it necessary to order the removal, reconstruction, relocation or repair of the encroachments, it shall be promptly undertaken at the sole expense of Birch Family Limited Partnership IV. Failure on the part of the Permittee to conform to the provisions of this permit will be cause for suspension, revocation or annulment of this permit, as the City of Medina deems necessary, and the City may remove the encroachment at the Permittee's sole expense. The Permittee agrees to indemnify and hold the City of Medina harmless from any claims by any person for personal injury or damages allegedly arising from the existence or maintenance of the encroachment.

No alterations may be made to the encroachments except that the **Permittee** may perform such routine maintenance as is required to keep the encroachment in good condition. If the encroachments are removed or destroyed, no new facilities shall be permitted to encroach on the public right-of-way of North Broadway Street without the express, written consent of the **City of Medina**. The encroachments for which this permit is issued shall be subject to all permits required by the **City of Medina**. Plans for the intended encroachments is attached to and incorporated into this permit. The intended encroachment shall be removed once the subject business, Ohio Real Title, leaves the subject premise at 100 Public Square (Permanent Parcel #028-19B-20-047).

EASEMENT DESCRIPTION Parcel 028-19B-20-047 100 Public Square Medina, Ohio

Situated in the City of Medina, County of Medina and State of Ohio, and known as being part of North Broadway Street Right-of-Way (99 feet wide), and more fully described as follows:

Commencing for Reference at the intersection of the westerly side of North Broadway Street and the northerly side Public Square (Liberty Street) (66 feet wide), at the southeast corner of Lot No. 82 of the Original Plat of the City of Medina, on the Medina Township Side of City; Thence, North 00°-26'-04" West along the westerly side of North Broadway Street, a distance of 69.65 feet to a point; Thence, North 89°-33'-56" East, a distance of 0.59 feet to the face of an existing 2 Story Brick Building, and being the TRUE PLACE OF BEGINNING of the parcel herein to be described;


Course No. 1: thence, North 00°-26'-04" West along the easterly face of said Brick Building, a distance of 2.99 feet to a point;

Course No. 2: thence, North 89°-33'-56" East, a distance of 12.75 feet to a point;

Course No. 3: thence, South 00°-26'-04" East, a distance of 2.99 feet to a point;

Course No. 4: thence, South 89°-33'-56" West, a distance of 12.75 feet to the place of beginning, and containing 0.0009 acres (38 square feet) of land more or less, as prepared in March 2018 by McSteen & Associates, Inc. under Project No. 18-032, and being subject to all legal highways and easements of record.

The basis of bearings for this easement are from GNSS observations to the Ohio State Plane Coordinates System, North Zone, NAD83 (2011) datum derived through the O.D.O.T. V.R.S. Network. Distances are given in feet and decimal parts thereof. All iron pins shown as set are 30-inch long 5/8-inch diameter rebar with an identification cap stamped "McSTEEN CA 96-026".


