Other than the Sergeants, the wages for each of the union agreements and what is being requested of Council to pass onto the non-union staff is 2.5% retroactive to January 1st, 2017, 2.25% in 2018, 2.0% in 2019. No increase to city for health care in 2017, proposed in the four contracts for union and non-union employees, a 1% increase of employee share in 2018, and 1% in 2019 dependent on City's insurance rates increasing by at least a percent or greater. Another change is every two weeks employees will get a portion of what they would earn for vacation. The Sergeants now will get a 1% increase and will not take effect until the contracts are executed. The roll was called on adding

This new unit will replace the 1993 that has served the city well. This unit is a street sweeper, a vacuum for catch basins and it also has leaf collection option which will be helpful in the fall. The roll was called and Ordinance/Resolution No. 076-17 passed by the yea votes of P. Rose, J. Shields, D. Simpson, J. Coyne, B. Hilberg, M. Kolesar, and B. Lamb.

They are looking to replace the 2000 tandem axil dump truck that has been in service for 17 years and has served the city well. The roll was called and Ordinance/Resolution No. 077-17 passed by the yea votes of J. Shields, D. Simpson, J. Coyne, B. Hilberg, M. Kolesar, B. Lamb and P. Rose.

Ord. 078-17:

An Ordinance prohibiting cultivators, processors and retail dispensaries licensed under Chapter 3796 of the Revised Code within the City of Medina, Ohio. Mr. Shields moved for the adoption of Ordinance/Resolution No. 078-17, seconded by Mr. Simpson. Mr. Huber stated that it is administratively the recommendation that we prohibit this activity at this time until the Federal Government acts with respect to marijuana possession and use. Currently federal law classifies marijuana as a drug of abuse, it's illegal to possess under federal statutes and the states have proceeded with authorizing activities that involve retail dispensaries and cultivation and processing without really addressing the fact that the federal law prohibits these activities. He and the Mayor have been sworn to uphold the laws of the state of Ohio and also sworn to uphold the laws of the United States and to simply ignore the fact that the federal law prohibits these activities and prohibits marijuana possession. Until the federal government acts, there is no exemption to possessing marijuana. His recommendation is to prohibit these activities until the federal government clarifies this issue. Mr. Kolesar stated for clarification the city had a 6 month moratorium on this issue and he voted in favor of that because it would give the legal department some time to catch up on what the state put into place. To put an overall ban on this knowing that it is a taboo subject here but he is not comfortable voting for. Mr. Lamb feels that what the State is doing and what the federal law is doing is in conflict with each other. Mr. Simpson will be voting against this partially for the same reason that Mark is voting against it. He feels since medical marijuana, which from his understanding will not be smoked, it will be an oil base and would benefit some people medically. He would have moved forward to extend the Moratorium but not banning. Mr. Coyne concurs with Mr. Simpson, having been through a few cases of cancer with close family members and others, the recreational use of marijuana he feels there is no place for that, but medical marijuana provides unique challenges and unique opportunities for those who desperately need pain relief. It is difficult to make a decision when you see people in those situations. Mr. Hilberg wants to clarify some things because he has been approached and asked why would he not be in favor of the use of medical marijuana for medical purposes, he stated this ordinance isn't saying the city is going to ban the use of medical marijuana but it is banning the cultivation and growing of it in the City of Medina. He agrees with Mr. Huber and the Mayor and for those reasons he will vote for this. Mr. Rose will be voting for this for the very reasons that Mr. Hilberg brought up. The roll was called and Ordinance/Resolution No. 078-17 passed by the yea votes of B. Hilberg, B. Lamb, P. Rose, and J. Shields. M. Kolesar, J. Coyne, and D. Simpson cast a nay vote.

- (b) The report, which shall be submitted not later than sixty days after the end of the state fiscal year, shall provide the total payment that was made from the fund, including the number of indigent consumers that received an alcohol monitoring device. The report shall identify the treatment program and expenditure for an alcohol monitoring device for which that payment was made. The report shall include the fiscal year balance of each indigent drivers alcohol treatment fund located in that board's area. In the event that a surplus is declared in the fund pursuant to division (H)(4) of this section, the report also shall provide the total payment that was made from the surplus moneys and identify the authorized purpose for which that payment was made.
- (c) If a board is unable to obtain adequate information to develop the report to submit to the department for a particular indigent drivers alcohol treatment fund, the board shall submit a report detailing the effort made in obtaining the information.

(I).

- (i) Each county shall establish an indigent drivers interlock and alcohol monitoring fund and a juvenile indigent drivers interlock and alcohol treatment fund. Each municipal corporation in which there is a municipal court shall establish an indigent drivers interlock and alcohol monitoring fund. All revenue that the general assembly appropriates to the indigent drivers interlock and alcohol monitoring fund for transfer to a county indigent drivers interlock and alcohol monitoring fund, or a municipal indigent drivers interlock and alcohol monitoring fund, all portions of license reinstatement fees that are paid under division (F)(2) of this section and that are credited under that division to the indigent drivers interlock and alcohol monitoring fund in the state treasury, and all portions of fines that are paid under division (G) of section 4511.19 of the Revised Code and that are credited by division (G)(5)(e) of that section to the indigent drivers interlock and alcohol monitoring fund in the state treasury shall be deposited in the appropriate fund in accordance with division (I)(2) of this section.
- (2) That portion of the license reinstatement fee that is paid under division (F) of this section and that portion of the fine paid under division (G) of section 4511.19 of the Revised Code and that is credited under either division to the indigent drivers interlock and alcohol monitoring fund shall be deposited into a county indigent drivers interlock and alcohol monitoring fund, or a municipal indigent drivers interlock and alcohol monitoring fund as follows:
- (a) If the fee or fine is paid by a person who was charged in a county court with the violation that resulted in the suspension or fine, the portion shall be deposited into the county indigent drivers interlock and alcohol monitoring fund under the control of that court.
- (b) If the fee or fine is paid by a person who was charged in a juvenile court with the violation that resulted in the suspension or fine, the portion shall be deposited into the county juvenile indigent drivers interlock and alcohol monitoring fund established in the county served by the court.
- (c) If the fee or fine is paid by a person who was charged in a municipal court with the violation that resulted in the suspension, the portion shall be deposited into the municipal indigent drivers interlock and alcohol monitoring fund under the control of that court.
- (3) If a county, juvenile, or municipal court determines that the funds in the county indigent drivers interlock and alcohol monitoring fund, the county juvenile indigent drivers interlock and alcohol monitoring fund under the control of that court are more than sufficient to satisfy the purpose for which the fund was established as specified in division (F)(2)(h) of this section, the court may declare a surplus in the fund. The court then may order the transfer of a specified amount into the county indigent drivers alcohol treatment fund, the county juvenile indigent drivers alcohol treatment fund, or the municipal indigent drivers alcohol treatment fund under the control of that court to be utilized in accordance with division (H) of this section.
