

ORDINANCE NO. 43-26

AN ORDINANCE AUTHORIZING THE MAYOR TO ACCEPT ELEVEN EASEMENTS NECESSARY FOR THE SOUTH HUNTINGTON STREET BRIDGE PROJECT AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEDINA, OHIO:

- SEC. 1:** That the Mayor is hereby authorized to accept eleven (11) Easements necessary for the S. Huntington Street Bridge Project.
- SEC. 2:** That the Temporary Easement marked Exhibit A, attached hereto and incorporated herein, is located on Permanent Parcel No. 028-19C-05-388, 233 Lafayette, FMVE \$1,650.00.
- SEC. 3:** That the Easement marked Exhibit B, attached hereto and incorporated herein, is located on Permanent Parcel No. 028-19C-05-388, 233 Lafayette, FMVE \$4,550.00.
- SEC. 4:** That the Easement marked Exhibit C, attached hereto and incorporated herein, is located on Permanent Parcel No. 028-19C-05-388, 233 Lafayette, FMVE \$2,140.00.
- SEC. 5:** That the Temporary Easement marked Exhibit D, attached hereto and incorporated herein, is located on Permanent Parcel No. 028-19C-05-129, 401, S. Huntington St., FMVE \$300.00.
- SEC. 6:** That the Temporary Easement marked Exhibit E, attached hereto and incorporated herein, is located on Permanent Parcel No. 028-19C-05-128, 375 S. Huntington St., FMVE \$300.00.
- SEC. 7:** That the Temporary Easement marked Exhibit F, attached hereto and incorporated herein, is located on Permanent Parcel No. 028-19C-05-382, 333. S. Huntington St., FMVE \$1,125.00.
- SEC. 8:** That the Temporary Easement marked Exhibit G, attached hereto and incorporated herein, is located on Permanent Parcel No. 028-19C-05-382, 333, S. Huntington St., FMVE \$485.00.
- SEC. 9:** That the Temporary Easement marked Exhibit H, attached hereto and incorporated herein, is located on Permanent Parcel No. 028-19C-05-395, 319 S. Huntington St., FMVE \$1,180.00.
- SEC. 10:** That the Easement marked Exhibit I, attached hereto and incorporated herein, is located on Permanent Parcel No. 028-19C-05-395, 319. S. Huntington St., FMVE \$465.00.

SEC. 11: That the Temporary Easement marked Exhibit J, attached hereto and incorporated herein, is located on Permanent Parcel No. 028-19C-05-396, 323, S. Huntington St., FMVE \$2,276.00.

SEC. 12: That the Easement marked Exhibit K, attached hereto and incorporated herein, is located on Permanent Parcel No. 028-19C-05-396, 323. S. Huntington St., FMVE \$6,224.00.

SEC. 13: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law.

SEC. 14: That this Ordinance shall be considered an emergency measure necessary for the immediate preservation of the public peace, health and safety, and for the further reason to get recorded and the owner paid as soon as possible; wherefore, this Ordinance shall be in full force and effect immediately upon its passage and signature by the Mayor.
