



MEDINA JULY 4TH PARADE REGISTRATION 2026

The City of Medina invites you to participate in our July 4th Parade. Each entry in the parade is encouraged to go all out – dress in your best patriotic flair and proudly display the American flag in honor of America’s 250th anniversary celebration!

The parade will be staged in the Medina High School parking lot on East Union Street (across the street from Sidney Fenn Elementary School).

There will be assigned rows for all participants and organizations pre-registered for the parade. You must pre-register to participate. NO EXCEPTIONS. Row assignments will be given to each participant on the day of the parade. No organization or person will be denied the ability to register for participation.

The parade will begin **promptly at 4:00 PM** from the high school parking lot, heading south on Spring Grove, then west on Liberty, and around the square. The parade will proceed and then end just past the Medina Library driveway on E. Washington Street.

For safety purposes, no candy or other objects may be thrown from moving vehicles. Walkers are permitted to hand out items. Additional regulations are specified in the Release Form.

Please note: In an effort to accommodate all entries, there is a one-vehicle limit per entity.

To register for the parade:

1. Complete one registration form per group. If you want to be in line with another participant, please indicate that on the registration form.
2. Copy the Release Form and have each participant or parent/legal guardian complete and sign it. Release forms must be turned in prior to participating in the parade. No one will be permitted to participate without a completed release form. Forms may be dropped off or mailed to the Mayor’s Office.
3. **Return all materials (registration and release forms) by Wednesday, July 1, 2026, to the Mayor’s Office, located at Medina City Hall, 132 N. Elmwood Avenue, Medina, Ohio 44256. Alternatively, you may scan and email the forms to: teckert@medinaoh.org.**
4. On the day of the parade, please arrive at the high school parking lot between 3:00 PM and 3:40 PM. An attendant will direct you to the appropriate row for your entry.
